RESULTS OF RECENT SALEM PJC DECISION:

The Stated Clerk reported on a recent DECISION made by Salem's Permanent Judicial Commission.

A member and ruling elder in a Salem congregation filed an allegation of irregularity against his Session – which had adopted a policy that categorically prohibited samegender weddings in that particular church. The complainant alleged that such a policy is in conflict with the *Book of Order*, Foundations of Presbyterian Polity, in that it discriminates against members of the church based upon their sexual orientation.

The PJC affirmed that "nothing ... shall compel a teaching elder to perform nor compel a Session to authorize the use of church property for a marriage service that the teaching elder or the Session believes is contrary to the teaching elder's or the Session's discernment of the Holy Spirit and their understanding of the Word of God" (W-4.9006)

Nevertheless, the PJC found that a categorical prohibition of same-gender marriage on church property is inconsistent with the process required by the *Book of Order*, W-4.9001-9006. The PJC was also informed by the provision of F-1.0403 which reads, in part, that "No member shall be denied participation or representation for any reason other than those stated in this Constitution."

The PJC found that the policy that categorically prohibits same-gender marriages is not in compliance with the *Book of Order* and, therefore, is void.

This DECISION is binding upon all churches in Salem Presbytery.
