### SYNOD OF THE MID-ATLANTIC 251<sup>st</sup> ASSEMBLY HIGHLIGHTS UNION PRESBYTERIAN SEMINARY

An amazing planning team contributed to an impactful Hybrid Synod Assembly held on Union Presbyterian



Seminary Campus, March 10-11, 2023. The Team included WD Hasty, Moderator Addie Peterson, Stephen Scott, and Vice Moderator David Cho. But when one adds Cindy Kohlmann, Connectional Presbyter (NEW) who staged and provided technical support, and Preacher and Presenter Cesar Carhuachin, March Madness had nothing on this Dream Team. The synod is blessed to

have such talented leadership who willingly promote the mission of the Presbyterian Church (USA).

**LAND ACKNOWLEDGEMENT**: The Synod Stated Clerk challenged the assembly to move beyond simple land acknowledgement to the next action step of repair and to provide reparation for Native American

church properties. In October 2022, twelve Synod Executives traveled to Utah, New Mexico and Arizona to view the buildings, churches and sacred land. The 223<sup>rd</sup> General Assembly called upon the Presbyterian Mission Agency to document the physical needs of all Native American church properties and create a fund for repairing those churches. The result documented that



approximately \$5.5 million dollars in repairs are needed to various churches. A Native American and Native Alaskan Fund <a href="https://www.presbyterianfoundation.org/nativeamericanchurches/">https://www.presbyterianfoundation.org/nativeamericanchurches/</a> held at the Presbyterian Foundation has been established for funding the effort to rebuild. The 225<sup>th</sup> General Assembly (2022) took action on Directing the Office of the General Assembly to Issue Apologies and Reparations for the Racist Closure of the Memorial Presbyterian Church, Juneau, Alaska. This action includes the reparation of \$220,000 to the Native American and Native Alaskan Fund which will be received from the PMA in 2023. Commissioners, Churches and Presbyteries are encouraged to contribute to the fund using the link above.

WORSHIP AND COMMUNION: Vice Moderator David Cho introduced Rev. Dr. César G. Carhuachín,

Mission Co-Worker in Baranquilla, Colombia at the School of Theology, Reformed University of Colombia as the preacher. The sermon was titled "Mission and Poverty." The Assembly was reminded of the missionary journeys of Barnabas and Mark to Cypress and Asia Minor and also how the Holy Spirit guided them to Macedonia. César is on a seven-month interpretation assignment in the United States which will allow him and his wife



(Dania) to visit churches, presbyteries, synods and other groups to share the work they are doing in Colombia, South America. The Lord's Supper was observed.

**SMALL GROUP DISCUSSION**: During the Hybrid Assembly, Commissioners, Corresponding Members and



Guests had several opportunities to participate in small group discussions in response to the five plenaries; even those on zoom, vigorously engaged in dynamic discussions. During plenary one and two, Dr. Alonzo Johnson, Coordinator for the PCUSA Self Develop of People Program, challenged all to explore ways that Matthew 25 intersects with the Poor People's Campaign.

The Synod and the Presbyterian Mission Agency previously drew on the knowledge and expertise of Dr. Liz Theoharis, Co-Chair of the National Poor People's Campaign in order to connect the dots. Dr. Theoharis was the key-note presenter during the 250<sup>th</sup> Synod Assembly last September. Alonzo's power packed an information filled presentation; it used professional and personal stories to illustrate how poverty connects to justice and how racism intersects with poverty. His guiding questions for breakout group discussions included (1) When you heard the word "Poor" for the very first time, what did it mean to you; and (2) Where do you see Christ among the poor? One commissioner raised a question during plenary as to what can the CHURCH do beyond discussion of these issues to impact laws and public policies? One way is to register and attend Ecumenical Advocacy Days which will focus on bringing about a more peaceful world. "Swords into Plowshares: Achieving Enough for All & Pursuing Peace" is the theme of the April 25-27 conference, Presbyterian Office of Public Witness in Washington, D.C.

PLENARIES THREE AND FOUR provided a deep dive into Matthew 25. David Eunil Cho and WD Hasty



delivered an eye-opening presentation on the Demystification of Matthew 25. Too many Presbyterians view the Vision of Matthew 25 as a political movement of the Left and because of this misguided understanding, resistance results. Some churches and presbyteries are already doing Matthew 25 work, but don't realize it. David and WD went to extreme measures to state what Matthew 25 is NOT! They provided conversation and strategies to implement Matthew 25 into churches and presbyteries. Three myths illustrated were (1) Matthew 25 is a Liberal and Political Agenda: Matthew 25 comes from Matthew 25:31-46, The

parable of the Sheep and Goats "Truly I tell you, just as you did it to one of the least of these brothers and sisters of mine, you did it to me". (2) <u>Systemic Issues are Not Real:</u> Do you believe there is systemic racism in America survey poll (Harris Poll – 2022) revealed that ¼ people did not believe and 53% white people were unconvinced that it existed. (3) <u>We can never be Matthew 25 Churches for ??? Reasons:</u> whether you identify as Matthew 25 or not, following God and doing what matters to God is a principle and calling, we've all been doing something that matters to God. This video and slides are posted on the website!

CELEBRATING MATTHEW 25: Dr. Cho highlighted stories and videos from churches and presbyteries

across the Synod that demonstrated the implementation of Matthew 25 and commissioners were captivated by them. CCC highlighted its Bilingual Youth Event, "When did we see you?" The program is providing workshops for youth to connect their passions with God. AKAP, Bethany Korean PC celebrates its Mission Team's building an indoor gym and multi-purpose center in Honduras for education and worship.



SHE, Trinity PC celebrates its Step-by-Step and Brick by Brick- unearthing the walls of a building to find bricks that were originally laid by enslaved people, uncovering building's past and the history of those indigenous and enslaved people of the land. WNC celebrates eight Matthew 25 churches and the presbytery addressing poverty, affordable housing, healthcare, and early childcare grants. Grants will help establish and develop building living space, and properties to serve those with low incomes. EVA, Kings Grants PC celebrates its Hunger Ministry Team and educational programs that support various efforts to



dismantle racism. It feeds the hungry and advocates for the marginalized. NHO, St. Paul PC is less than 40 members situated in rural Franklin County NC. 20% of the children here live in food insecure families. Hunger is one of the first signs of poverty. Since March 2020, 35 bag lunches are provided for the homeless; it consistently hosts full-service events that feed hundreds. In 2022, they served 5137 families that represented

14,819 individuals. They have self-service facilities in two refrigerators in our walk-up pavilion that are on a 'take what you need basis'. The church has resumed serving hot meals once a week to 50-60 people

in Blessings Soup Kitchen. Synod of the Mid-Atlantic celebrates allocating \$150,000.00 to support presbyteries (a) Becoming a Matthew 25 Presbytery, and/or (b) Move Matthew 25 to the next level, or (c) Assist Churches to become Matthew 25. Black, Indigenousness and People of Color Churches (BIPOC) are allocated \$52,500.00 to develop leadership skills. Many congregations in presbyteries are doing Matthew 25 work, but have not formally embraced being Matthew 25. We wait for other churches to fully embrace the Vision of the Presbyterian Church USA to share your stories.

PLENARY FIVE: Mission Co-Worker César Carhuachín shared an international perspective on poverty from

the ministry which he serves. Steps away from the Reformed University where he teaches, he comes face to face with some of Columbia's most marginalized people. He encounters Venezuelan refugees who seek to survive by selling candy on the streets. The United Nations estimated that 3.4 million Venezuelans have fled their homeland, where political repression has created severe economic hardship and shortages of food and medicine. Carhuachín expounded on biblical themes such as neighbor love and God's concern for impoverished people. Beyond the Barranquilla campus, he puts



the teaching into practice among the refugees. He engages them on the streets and in their homes, in his home and in Columbia's Presbyterian congregations. According to the United Nations, the highest number of Venezuelan refugees-more than 1 million- are living in Columbia.

**SCHOLARSHIPS**: Emails have been received from college/seminary recipients from the 251st Synod



Assembly. "Thank you so much! I am thrilled to know that this support will continue. It is very much appreciated. I will also mail a thank-you note to the Grants Committee." "I am so excited!!! The note will be coming shortly." "I am sincerely honored to have been selected as the recipient of the Euler scholarship 2023-24. Thank you for your generosity, which will allow me to concentrate more on my studies and fulfill my calling to the Christian ministry." Stultz and Euler Scholarships awarded \$31,000 to students enrolled in PCUSA

colleges and seminaries. They included Rien Freeman (SAL- \$5,000.00), Joshua Gilhart (BAL - \$7,000), Kanyugi Gichuki (JAM - \$7,000), Andrew Hall (NAT - \$6,000), and Donna Graves (EVA - \$6,000).

**SMALL CHURCH GRANTS:** Totaled \$20,000 and enabled the following churches to address important mission projects: Anderson Memorial (ABI) was awarded \$5,000 for Handicap Accessibility; Hamilton PC (BAL) was awarded \$5,000 for flooring replacement; Reid Memorial PC (SAL) was awarded \$5,000 to replace an HVAC system; and Sweetwater PC (WNC) was awarded \$5,000 for steeple/roof repairs.

**KATE B. RENOLDS TRUST:** Totaled amount awarded was \$665,765.06. 446 Honorably Retired Ministers in North Carolina Presbyteries each received a distribution of \$1,492.75.

**FINANCES:** Synod 2022 revenue and expenses were in line with the budget. The Assembly approved the following: (a) Automobile reimbursement was increased to 65.5 cents/mile. (b) Granted \$20,000.00 to AKAP for expenses associated with legal matters. (c) Amended the 2023 budget by \$10,000 to provide for communications/publications costs. (d) Synod per capita rate remains at \$1.15 for 2024. (e) A future discernment discussion be held during Assembly regarding possible per capita increases.

**NOMINATIONS:** Presbyteries are asked to ensure that your presbytery is represented on synod committees and commissions. The following leadership was approved: WD Hasty and Felicia Hoyle are Administration Committee Co-chairs; Amanda Pine and Cassandra Thomas are Emerging Ideas Co-Chairs, and Tom Holden and George Hall are Committee on Representation Co-Chairs.

SYNOD EXECUTIVE/CLERK: Female Executives and Stated Clerks were recognized for Women's History Month. ABI and BAL are in compliance with synod standing rules. Synod leadership participated in a consultation with AKAP and Office of the General Assembly concerning remedial complaint and civil case. Presbytery updates: ABI – is a Matthew 25 mid-council; NHO - Bruce Grady, Executive Presbyter; NAT - David Baer Stated Clerk; NEW - Gifted the synod with \$30,000; JAM - Steven Hicks, Stated Clerk; SAL - Formed Executive Search Committee. There are nine civil cases that synod is named as a defendant. Presbyterian Leader Formation includes Floretta Watkins, Elyse Hicks and Bruce Grady and synod pays \$1,500 annually for the three-years. SPJC has three remedial complaints. Executive Committee addressing ministry areas: (1) To Enhance Leadership Skills among Committee Chairs; (2) To Develop a Comprehensive Marketing and Communications Plan. (3) To Address Organizational and Structural Changes necessary so that Matthew 25 might flourish across the region.

**REMINDER**: Every commissioner represents a particular presbytery. Commissioners are the presbytery's

access to the work and mission of the synod. Assembly meets twice annually. Commissioners are expected to report synod actions to the appropriate presbytery body following each assembly. Feel free to share this document with the appropriate bodies and churches across your presbytery. Both Word and or PDF copies are included! On behalf of all the commissioners, corresponding members and visitors to the 251<sup>st</sup> Synod of the Mid-Atlantic Assembly we extend immeasurable gratitude and appreciation to Moderator Addie Peterson and Vice Moderator David Cho for their incredible leadership. 


Eastertide Greetings Salem Presbytery!

Our vision states that this presbytery serves as "a catalyst for transformational ministry." It has now been a year since the position of Designated Presbyter for Transformational Ministry commenced service, with a focus on churches without installed ministries.

I have worshipped and/or met with 33 of our churches without installed ministries. We learned these churches comprise the majority of our Presbytery (54%) and that our African

American churches are disproportionately impacted (79%)<sup>1</sup>. We developed the Church Empowerment Assessment (CEA), now completed churches, and initiated 3 Shepherding Teams to alongside churches working through difficult decisions.

Two churches requested dissolution (Covenant and Stoneville). The voice of the Black Caucus has been regenerated after COVID. A Call to Conversation was hosted for Installed Ministries in February 2023, another will be hosted for Uninstalled Ministries May 6<sup>th</sup>, and one is planned for Hispanic Ministries in October (2023). Our work together continues as we seek to strengthen our faith family as we

renew our understanding of core PCUSA beliefs.

Many of you have extended great grace to me in sharing your thoughts or pointing me to others who have shared their thoughts. *This is what we in the PCUSA hold as our (human) energy source: being relational and connectional.* We are chasing huge windmills of theological wholeness these days. Transformation is not the work of one person, one committee, or even the churches struggling the most. In honoring our beliefs,



we understand that transformation must be embraced by all of us, together. We are the priesthood of all believers: "Everyone is just as spiritual, just as capable of speaking to God, and just as called to deliver God's message to the world. Everyone is equally called to do God's work and to minister to God's people." <sup>2</sup>

We are Easter People, believing the impossible is possible: that life springs from death,

that light overcomes darkness. don't, we are just practicing every church has the call to pandemic ministries must be being, to witness to the

For over 30 years, El Buen Pastor Presbyterian Church has been a spiritual home, extended family, and community center serving Latino/a immigrant families in Winston-Salem. Our ministry includes:

- Spanish-language Sunday worship and Sunday School for children
- Spiritual growth for all ages through Bible studies, a prayer group, and young adult gatherings
- Art and music classes for children from the church and surrounding community
- Pastoral care and assistance connecting families with community resources for housing, education, medical and mental health care, legal services, and more.
- Leadership development El Buen Pastor ordained its first class of four Deacons in January 2023, and three more leaders have been elected and are in training.
- Community organizing through the NC Congress of Latino Organizations (NCCLO) and the Forsyth Sponsoring Committee (a multi-racial, multi-faith coalition of civic institutions dedicated to strengthening relationships, developing leaders, and organizing for justice).
  - El Buen Pastor was part of <u>a successful NCCLO campaign to add bilingual staff, counselors, and social workers</u> in Winston-Salem/Forsyth County Schools.
  - The congregation is currently participating in campaigns to bring a primary healthcare clinic to the Old Town neighborhood and expand mental health services for Spanish-speaking residents across Forsyth County.

El Buen Pastor is a ministry of Salem Presbytery but does NOT receive an operating budget from the Presbytery. Therefore, as the work of El Buen Pastor Church grows to meet the needs of our community, we are inviting Salem Presbytery congregations to partner with us in ministry to the Latino/a community. Our needs include:

- Connections with additional congregations to share in worship and fellowship
- Volunteers willing to teach visual or performing arts to our children on Thursday evenings
- Regular financial support Our annual budget is currently \$100,000. About \$20,000 comes from congregational tithes, offering, and fundraising activities. The remaining \$80,000 must be raised from partner churches and individual donors. In addition, we would like to increase our budget to properly compensate our Director of Christian Education. Ana Santos, Rev. Jorge's wife, is a gifted, seminary-educated minister. She currently works full time, with no compensation, leading a women's Bible study, children's Sunday School, the art and music program, and more. Our Steering Team believes it is only right and just that she be supported for her work.

For years, just four partner churches (First Presbyterian in Winston-Salem, Highland, Clemmons, and Shallowford) have provided regular support to El Buen Pastor totaling about \$50,000/year. **Our goal is to dramatically increase the number of churches in the Presbytery that actively support El Buen Pastor with annual gifts to sustain this vital ministry.**

### Revs. Courtney Stevens and John Senior, Co-Moderators

### The CPM moves the following motion:

1. That candidate Taylor Austin be considered to have completed his Candidacy as of May 16, 2023, subject to the provisions of Book of Order G -2.0610, "Accommodations to Particular Circumstances."

### Background and rationale:

Taylor Austin entered the ordination process in October 2020 and advanced to the candidacy stage in the November 2022 meeting of the Salem Presbytery. He graduated from Princeton Theological Seminary in May 2019, having already completed ordination courses with the foresight that he would pursue ordination after seminary. In 2021, Taylor's ordination timeline was delayed as he changed congregations and came under the care of Westminster Presbyterian Church's (WPC) Session. CPM requested that he participate in a follow-up psychological assessment, continue in his work with his therapist, and become more connected to WPC before being moved to Candidacy. Taylor willingly obliged each of CPM's requests and fulfilled each item with a spirit of openness. In January 2023, Taylor completed his final ordination exam (Biblical Exegesis). The CPM is now satisfied that Taylor has completed all requirements related to the ordination process and is ready for his final assessment.

Ministry Development Service experienced a backlog of work owing largely to the pandemic. For that reason, Taylor was unable to schedule the follow-up psychological assessment, which the CPM requested, for more than six months after the CPM made the request. Taylor completed this task last fall.

The *Book of Order* requires that the total duration of the ordination process be at least two years and that the duration of the Candidacy phase be at least one year (G-2.0602). Rather than penalize Taylor for timing issues outside of his control, and thus delay his movement to the Certified Ready to Receive a Call (CRRC) stage, the CPM is requesting that the Salem Presbytery vote to truncate the Candidacy phase in Taylor's case such that it concludes at the date of the May 2023 presbytery meeting (i.e., May 16, 2023). Should the presbytery vote to sustain this motion, the total duration of the ordination process in Taylor's case will still be more than two years.

### Additional Report:

Finally, the CPM reports the following item:

In its March 2023 meeting, the CPM voted to enroll Nolan Chilton, member of First Presbyterian Burlington and student at Duke Divinity School, in the inquiry phase of the ordination process.

### The Rev. Bonita Clark Quandt

**Faith Journey** 

First, I gave as I received. God birthed me into a family of believers in Jesus Christ. My parents received faithful training through Methodism, but I came when they were not yet established into faithful personal practice. So, my grandparents arranged in my toddler years to instill a regular pattern of corporate worship while my mother taught me Scriptures and my father exemplified a Christian worldview. Through them, the seeds they planted were grown by God to form within me a trust that I am God's and beloved.

The community church nurtured me and taught me to live strong for Jesus. In my anxious teen years, when I could not find validation in school, I found it in my church family. I launched from high school into college with a solid faith and a prayer for a Christian friend. God answered with favor. Although disconnected from home, I found connection through new acquaintances and exposure to new ways.

By graduation, I was married, found a career, birthed a child, and desired to raise him in the faith. God drew me to a specific church that opened my heart to Jesus' call and nurtured my son and I through a divorce and remarriage. This church was PCUSA, and I was invited to use my talents abundantly. Here, I became an Elder, learned my deep need to partner with Jesus in matters of social justice, and shaped a new life in trust that God indeed is the only resource for what I have in life. I attended presbytery, volunteered in interfaith programs, and served the homeless. God created within me a passion for helping others.

A call story formed in the aftermath of my husband's firefighter duty injury, a lynchpin of change. He was disabled with permanent compensation for life. We chose to move away, taking me from my career. Our relocation gave us blessing of reuniting with my family, and a similar career position that was not as enjoyable. A new PCUSA church community received us and nurtured us. As an Elder, I preached and a member asked why I was not in seminary. God used those words to ignite a call to ministry for me. I pursued the call, and I graduated from seminary as my son graduated from college, and my husband provided all support possible to do so.

My first call to ordination was to serve a church known to be difficult. It was. Yet, God used me to touch so many lives. Some came to deeper faith, some adults came to faith to be baptized. Many children were baptized. The community included a state women's prison, where I preached monthly. I participated in Kairos prison ministry. A beautiful group of peers from Presbytery gathered monthly with me to breakfast, pray and share. Although this church also rejected me, the outcome was that Presbytery intervened and the cycle of clergy abuse subsided.

God led me to other churches, each for a fruitful season. I found gifts of giving and mercy within me. My ability to write provided a season of creating Christian education materials. My ability to create produced new audio/visual ways to present the Gospel.

I retired, but God continues to use me to minister to others. I insert myself into churches and continue to use these talents for Christ to spread the good news. Praise be to God.

#### The Rev. Bonita Clark Quandt

Statement of Faith

I believe.

God is Almighty, Eternal Love, and Creator of everything, including us. As Author of life and Authority over all, God possesses all, including us. God desires us to be close, proven in past covenants. First with Noah, God promises to never again wipe out creation to end wickedness. Then with old Abram and Sarai, God promises a child and makes from that offspring a nation known as God's people. And with Moses, God renews the Abrahamic covenant with new commandments for living according to God's ways.

Holy Spirit is Sustainer of humanity and the Breath of God. Regenerator of humanity, Holy Spirit is eternally available to initiate faith and transform us into new beings. Moses cried out to God for help, and God sent a portion of Spirit to anoint 70 elders to help. Ever present is the power of Holy Spirit to draw us close to God as teacher and sustainer of faith.

Being fully God, Jesus taught us with authority how to love God and be love to everyone else. Jesus' fully human life exemplified true obedience to God and complete love for us. Boldly, we live within a sinful and broken world as people set apart by God through sanctification. Connected to God by the power of the Holy Spirit, we are better able to refrain from sinful behavior. But when we miss the mark, we may confess our sin to God and gratefully receive forgiveness.

Sacraments are significant, particular times marked by God as a visible sign of covenantal connection to the Triune God. Participation in sacraments marks a sacred moment deeply connecting us to the Holy Trinity. The Sacrament of Baptism formally marks the occasion of one's public renunciation of sin, one's promise to live in God's realm, and being God's own. Common water is the sign of washing away sin's stain. A Trinitarian formula is pronounced as water is applied. This is a visible seal of an eternal new covenant of life in Christ Jesus, only done once.

The Sacrament of the Lord's Supper is the mark of remembering Jesus who lived, died and resurrected for us. With the sign of bread broken and eaten, we remember Jesus' saving death. Likewise the cup which we drink is sign of Jesus' new covenant with all. As often as we eat this bread and drink this cup, Jesus seals us unto himself and with all saints for which we worship and praise Him.

Where two or more are gathered in Jesus' name, there is the church. The church is a community that is not immune to the state of sin in the world, yet serves as a conduit of faith-building and sanctification. When purposeful gathering of believers includes worship, scripture and the sacraments, we thrive and grow in God's grace and love.

Evelyn R. Crews Faith Journey

As a child of a busy, single mother, I did not grow up in the church. My mother was a young divorcee in the early 60's and felt ostracized from communities of faith, yet my own experience with God began early in life. Due to certain circumstances, I experienced God as a presence and a still small voice, though I did not know what to call these experiences at the time. I knew the presence and voice were "other," and was a source of comfort for a child in need of comfort and love. These memories have never faded and offer me the complete conviction that God is a real, active, life-changing presence in our lives and we are to be that love and presence for others, especially those in greatest need.

When I began to be more aware of church through occasional visits with friends as a child, I found that I loved the story-telling and how the words and stories of scripture made me feel. Eventually, my older brother and I attended a nearby church together and I was baptized there at the age of 16. My community of faith offered much of what was lacking elsewhere, though I still had questions and concerns. Having been raised by a strong mother who served the community through social work, I questioned what seemed to be a secondary role of women in church and community. Following my mother's example, I grew to work in the world of nonprofits, particularly those in service to the homeless population. It was through my work as the director of an organization that served homeless families that I received my call to ministry and applied to divinity school at Wake Forest University. At the same time, I served as an Outreach Minister at a Baptist church and was eventually ordained there. I initially desired to return to the nonprofit world after graduation, better equipped to meet the many needs of community, but fell in love with the difficult but intimate work of chaplaincy through CPE.

CPE took me to work in a large urban hospital, and a smaller community hospital where I came to offer Spirituality and Art classes in the hospital cancer center as a path toward healing and wholeness. It was while I was serving in this ministry, that I answered an ad for a position at Springwood Presbyterian Church, which was the beginning of an unexpected call. At Springwood, I began in administrative work but was quickly given the grace and freedom to grow into pastoral care, delve into placemaking and program development, Vision 2020 implementation, and was coached and encouraged to preach, something I never thought I would do.

In another surprising call from God, I was invited to be the lead minister of a rural Baptist Church and have learned so much in my year here. I have gained confidence in preaching and program development and my desire to proclaim God's call to inclusivity, hospitality, social justice, and interfaith dialogue. God continues to provide opportunities for spiritual growth through creativity and self-expression, and I continue to hold onto that still small voice saying all of God's creation are deeply loved and valued. Springwood Presbyterian Church is once again central in my ministry journey as the proposed Vision Implementation Pastor. My true love in ministry is found in the sacred moments spent with others during pastoral care, the moments of our greatest need. Second to pastoral care, I greatly enjoy creating, implementing and teaching community classes that invite others into the presence of a knowable God of love, compassion, and forgiveness. My own journey has brought me to this place.

Evelyn R. Crews Statement of Faith

I believe in the Triune God, one in three - God the Creator, Jesus, the Son, and the Holy Spirit. The Rev. Dr. Matt Bussell Faith Journey

My family joined First Presbyterian Church of Grand Haven, MI when I was three years old, and I have been Presbyterian ever since. I grew up attending church every week, learning the stories of Scripture in Sunday

School and by staring at the stained-glass windows throughout worship. As a youth I enjoyed not only the weekly youth group meetings, but the lock-ins, mission trips, and summer conferences. The church was a second family for me which taught me the Christian faith.

When looking at college, I decided early that I was interested in a Christian liberal arts education and attended Calvin College. At Calvin, it took me some time to figure out the direction of my studies, going from engineering to education to religion to finally settling in with a history degree. While I worked out my focus in the classroom, outside I found myself heavily involved in the campus ministry programs. Toward the end of my time in college, I was discerning between graduate school for history and seminary, and ultimately felt called to attend seminary. Having spent my entire life in West Michigan, I decided to move to a new area to attend Columbia Theological Seminary in Atlanta.

I entered the ordination process with a lot of questions. I fell in love with theology at Columbia but was not sure that congregational ministry was the best fit for me. This apprehension was reinforced during my supervised ministry in a dysfunction congregation with a manipulative supervisor. I decided to pursue doctoral studies in service to the church rather than congregational ministry. Following a year doing a Th.M. at Duke, my wife and I moved to southern California for me to enter the Ph.D. program at Claremont Graduate University. As I was deepening my understanding of theology in my Ph.D. coursework, I also found myself drifting away from the life of the church. The PC(USA) had moved to become more inclusive of the LGBTQIA+ community and the congregations in our area were fighting about who to exclude and considering leaving the denomination. For the first time in my life, I was without a church home. I still had faith, yet I did not have a faith community.

Following the completion of my coursework and qualifying exams, my wife and I moved back to North Carolina to live with her parents in Tarboro. My father-in-law was serving as the interim minister at Howard Memorial Presbyterian Church at the time. This church welcomed us with open arms and provided the connection to a local congregation I had been missing in California. They supported us as we welcomed our daughter and encouraged me to participate in the life of the church. This church helped me see that all my theological studies could be used in the church, something that I had forgotten in my time away. They helped me hear again the call of God to congregational ministry.

I was ordained as a minister of Word and Sacrament by Pittsburgh Presbytery in March of 2016 to serve Covenant-Community Presbyterian Church. CCPC was a small congregation struggling to survive yet full of loving and kind people. At CCPC I learned to enjoy preaching, the holiness of funerals, and the delight of teaching. I also learned the importance of community with other church leaders as I navigated the joys and struggles of serving that congregation. In September of 2018 I started a new call at First Presbyterian Church in Jonesboro, AR. FPC Jonesboro is a healthier congregation set in a difficult ministry context. Jonesboro is town of fundamentalists with the Presbyterian and Episcopal churches being excluded from community church events. Yet the people in the church are loving and compassionate, seeking to care for the poor and marginalized in a community where they blamed and derided. FPC Jonesboro has supported me in completing my Ph.D. and involvement in the wider church with the Presbyterian Mission Agency Board.

In the seven years that I have served in congregational ministry, God has slowly transformed my faith. I entered ministry as a doctoral candidate in theology with a love of abstract theology. While I still love theology, my focus has changed to how it is lived out in the community of faith. I see abstract theological notion of love lived out in the concrete encounters with my neighbors and joining the work for justice and equity. Where my faith used to focus on what I believed, it is now focused on what I and the church do to join the mission of God in the world.

The Rev. Dr. Matt Bussell Statement of Faith

I believe that the Triune God created the world out of nothing. The Father is primarily responsible for the act of creation but the Son and the Holy Spirit also participate. God did not create out of primordial matter or with

another being but rather out of nothing. God has the ultimate authority and is the source and sustainer of all things.

Humanity is created in the image of God. We are created good and with freedom. God created us to be in relationship with others and God as a community of mutual love, justice, and peace. Sin tarnishes our ability to live as God created us. When we, individually and as a community, destroy relationships through behaviors such as greed, selfishness, oppression, prejudice, and self-devaluation, we alienate ourselves from each other and God.

In Jesus Christ the Eternal Word of God was incarnate, becoming human as the ultimate expression of divine love. Throughout his life and ministry, Jesus shared the vision of God's Kingdom for the world based on community and love. His teachings angered the religious and political elites who viewed him as a threat. They conspired to execute him on the cross. Three days later he rose from the dead and later ascended to reign beside God the Father. Through his life, ministry, death, resurrection, and ascension, Christ reconciles humanity with God and one another. The ultimate experience of alienation in death is overcome in Christ as he paid the penalty for our alienation from God and foreshadows our resurrection to new life. We have hope for the future because of the resurrection of Christ. After death we will be united with God. This resurrection we anticipate is not the rising of our souls to heaven but a bodily resurrection.

It is through the Holy Spirit that we come to know Christ. The Spirit unites us to Christ, enabling us to receive Christ's benefits. Through the Spirit we are justified by grace, through faith. The Spirit works in us through grace in our sanctification.

The source of our knowledge of God and God's work of redemption in history is Scripture. Scripture is the Word of God, inspired by God but written by people. Scripture has been written, edited, translated, and interpreted by people who are prone to error. It is therefore the Word of God insofar as it points to Christ. In Scripture we learn of God's character and actions; it is in Scripture that we know God's grace.

The church is the body of Christ on earth. Though there are many denominations, together they constitute the body of Christ. It is through the church that we participate in the community of believers and receive the sacraments. The sacraments are signs that point to God. Baptism is a sign of God's covenant with us while Communion is a sign of Christ's incarnation, death, and resurrection which unites us with God. Christians are not called to be solitary but in community, building each other up in love. We are called to be agents of God's reconciliation, justice, peace, and love in the world.

Michael Sarvis Faith Journey

My Faith Journey began in the city of Atlanta when I was in 4<sup>th</sup> grade, attending "The Billy Graham Crusade" with my brother, parents, and our neighbor who invited us. My parents grew up in the Christian Faith but had fallen out of it during their early adult lives. I remember nothing about attending this event. I only remember it as the catalyst for both of my parents rededicating their lives to Christ and ended my streak of Sunday morning cartoons. From this point forward we were at church every chance our family got. We began attending a small Southern Baptist church within a few months both me and my brother were baptized. Looking back at my baptism I don't remember much outside of choking on the water as the pastor dunked me. I think it is possible I just did this because it was expected of children this age in the church, I can't say one way or another. Shortly after that we started attending a Presbyterian church in town and this is where my faith really came to life. I met a boy who embraced me like no other person my age had before. He was kind, funny, and celebrated me for who I was. He was the first person outside of my family to truly treat me like Christ would have. I have always been partial to the story of Jesus and the blind man in John 9. As a young person I felt like the blind man — misunderstood and gossiped about. I feel strongly that Jesus getting level with the man and touching his face is a very important part about the Christian faith. We are called to love and serve one another, and it is not possible

to do that if we are stuck behind barriers. This was the first time in my life I didn't feel any barriers between myself and a peer.

My friendships that grew from this boy empowered and grew my faith. I learned what true friends were through my experiences at church. My parents and brother loved me but knowing people who weren't my family also loved is what grew the curiosity in exploring my faith. I became interested in service and helping others and wanted to extend to others what had been extended to me through my friends at church. This is ultimately what made me want to pursue a career in the church, and how I became exposed to and fell in love with the reformed tradition. Time went by, I graduated and went to college and while in college took an intern position, a youth director position at a small church, and then an interim youth director position that ended up being a position that lasted 8 years. I then took the job where I currently work and went to seminary. I graduated seminary in 2018 and have been affirmed by my current congregation into my call for preaching and teaching.

I think my faith journey is a bit unique as I began working and serving in a ministry context at a young age. Being a 20-year-old "youth pastor" was a recipe for disaster but these experiences and the people I met along the way really brought the gospel to life for me. It was through my own missteps and interacting with people who didn't like or value me I was able to better understand the person of Christ.

Michael Sarvis Statement of Faith

I believe in a Triune God that is God the Father, God the Son, and God the Spirit. I believe God the Son is the incarnation of the Triune God as the person of Jesus Christ. I believe I am a sinner in need of saving. I believe God does not share the human prejudice and division humanity struggles with. Christ's birth, ministry, death, and resurrection are acts of God showing God's love for creation and humanity. Jesus Christ is the vessel God has used to reveal to us God's power, spirit, and love – these things are the culmination of God's grace and what have saved me from my sinful nature. This encourages me to abandon human prejudice and division. I believe Jesus Christ's life and ministry represent grace, compassion, and liberation and we have been commanded to carry this message to the end of our lives, and follow Jesus as the ultimate example of how one is to live their life. I believe God loves every human being and that love is magnified through Jesus Christ. I believe the church is the body of Christ. I believe the church is to model its community through study of canonical scriptures, acts of grace, love, and compassion. I believe these actions embody the Spirit of God. I believe every follower of Christ is an integral part of the body of Christ – called into some form of action or work that shows the world we are disciples of Jesus Christ. I believe the church is to try and always care for the poor, downtrodden, outcasts, and sick – regardless of what has brought them into these circumstances. The church's action of service stands to serve as a tool that deepens our understanding of God's love for us. In addition to various acts of service, I believe the church is to also proclaim God's love for us in the form of The Lord's Supper. I believe this meal welcomes and waits on us despite our sinful nature.

I believe baptism is the sign and seal of our faith, this symbolic action follows the model of Christ's death and resurrection. #### My Journey

Two truths have been central to my life and have more meaning to me today than when I started my ministry 25 years ago: (1) God is sovereign and (2) I am loved by God, the Father.

With age and maturity, I am learning that life is unpredictable. Rather than an upward and straight trajectory, life is a winding, ascending, and descending journey. Yet through it all, God is sovereign. God is in control. I know that in all things God works for the good of those who love God, who have been called according to his purpose (Romans 8:28).

God is sovereign in my trials and God is sovereign in my joys. God is sovereign in my mountain-top experiences and God is sovereign in my darkest hours.

God works to benefit me and not to harm me (Isaiah 29:11). This truth leaves little room for regrets. God's goodness and mercy enables me to be at peace about my past, present, and future. I know I am fully loved by a sovereign God who has wonderful plans for me to discover.

#### My Multiculturalism

At the beginning of my pastoral career, as a Korean-American, I followed the tradition and served in immigrant Korean churches. However, by doing so, I was not able to engage in other aspects of who I was and had passion for, especially my heart for every people, nation, and tribe.

As I grew as a minister, I was able to expand my wings. Not only have I served in ethnic immigrant congregations, but I have also been at white congregations, African American congregations, small in number to a several thousand-member churches. I've preached to elementary aged children, youth, college, and to those in their 90s. Moreover, I was a director at a seminary and other non-profit organizations, which gave me a perspective outside the church.

My multiethnic and multicultural background, unique experiences, and ability to connect with people from different races, ages, and vocations allow for flexibility, openness, and creativity in the way that I serve.

#### My Service

My passion, enthusiasm, and genuine love for Jesus, His Church, and His people are paramount to who I am. My mantra in my life has always been to be FAT: faithful, available, and teachable. I will bring this attitude of humility, availability, and teachability to the church that I am called to serve now.

The Rev. Peter Kim Statement of Faith

#### God, the Father

I believe in the first person of the Godhead: God the Father, who is the Almighty Creator of all things. God desired to have fellowship with humanity; hence, God created man and woman in God's image (Imago Dei) to have eternal fellowship with the Creator.

But the man and woman sinned in disobedience. Consequently, they were alienated from their Creator, broken of their fellowship, and eternally separated and condemned.

In mercy, God sent messengers, prophets, priests, judges, kings, and other servant-leaders to woo people back, but to no avail. Something had to be done to reverse God's judgment and condemnation.

Jesus' purpose/mission was to forgive our sins by dying on the cross as our substitute in order to satisfy God's divine justice and accomplish salvation for all who trust in Jesus. Thus, Jesus restored our broken fellowship/relationship and reconciled us to God.

I believe salvation is received by having faith *in* Jesus, as well, Jesus' *faithfulness to* us- and not by our works. We are saved, justified, and made righteous *through* God's grace.

I believe that Jesus died and rose again from the dead on the third day, ascended into heaven, and now sits on the right hand of God the Father.

Jesus promised that he would send the Helper (Paraclete), who will guide, direct, and convict people of their sins.

#### God, the Holy Spirit

Therefore, I believe in the third person of the Godhead: God the Holy Spirit, who continually convicts us of our sins. I believe we are all in need of renewal and rebirth by from the Holy Spirit.

I believe in the indwelling presence and transforming power of the Holy Spirit, who gives to all believers a new life and a new calling to obedient service.

#### **Holy Scriptures**

I believe in the Holy Scriptures- the Word of God written and fully inspired by the Holy Spirit for God's people. It is God's revelation for our salvation and our divine guidance for life and faith.

#### Holy Communion

I believe as followers of Jesus Christ, we are called to remember what Jesus did on the cross as we take bread and the cup and celebrate God's grace to us.

#### **Baptism**

In baptism we are united with Jesus Christ and the Church. It is an outward sign/testimony of God's grace and faithfulness for God's people. In baptism we testify that we have been crucified with Christ and we are resurrected with Christ to new life.

#### The Church

I believe the Church is the espoused Bride of Christ, the living Body of Christ on earth; where Christ is the head and source of life. The Church exists to celebrate the living God, cultivate personal growth in Christ, love one another in Christ, and communicate Christ to the world through words and deeds, and making disciples of all nations.

#### The Second Coming

I believe in the Second Coming of our Lord Jesus Christ. I believe Jesus will come and reward the faithful ones, and say, "Well done my good and faithful servant. Come into your rest." Thus, we cry out with the cloud of witnesses: "Come, Lord Jesus."

My earliest memories are of church. Mom was the organist of our small country Presbyterian church in Sykesville, Maryland, and Dad was a Deacon (in the days when Deacons were the equivalent of Trustees). (Later Dad was an Elder/Chair of Worship/Clerk of Session. Later still, Mom was ordained an Elder.) I learned my faith, and it was nurtured by worship (hymns and the Apostles' Creed which I could recite by age three), my family, kind pastors, and the people of the church; I was probably about six years old before I realized that they weren't all related to me.

My journey of faith has been a constant journey throughout my life. It has taken me on many highways and byways, including high peaks and "sloughs of despond." It has taken me to an Episcopal boarding school (7-12 grades), Presbyterian Church camp, Presbyterian college (Florida Presbyterian/Eckerd), six years as a chorister in several Anglican churches, a conservative bible college (in London), Princeton Theological Seminary, and finally brought me into the UPCUSA (later PCUSA) as a newly minted M.Div.

I went to Seminary searching; I felt a Call during my Field Ed (Seminary Intern) experiences. My faith grew as I learned and experienced more about the love of the Triune God through my Seminary studies, daily chapel services, interaction with colleagues/peers, and the mentoring of my Field Ed supervisors.

Thirty-eight years as an active Pastor in the same Presbytery (Monmouth, NJ) showed me many sides of the Church, and sometimes my faith was severely tested. My Call and my faith stayed strong and I grew in trust that God was always with me...except for one time, when I was so wounded by the church that I felt empty, and for that period of time, my faith was carried for me by my colleagues and my loving congregation, until I emerged stronger; looking back, I know that God was with me in that wilderness.

Now, in retirement, God is, as God always is, as close to me as breathing. My journey in faith will continue beyond the bounds of this life. "Were the whole realm of nature mine, that were a present far too small; Love so amazing, so divine, Demands my soul, my life, my all." Issac Watts, 1707

#### The Rev. Suzanne Schafer-Coates

**Statement of Faith** 

Before the dawn of time, the Lord God began to create. How God formed every thing that exists, earth, sky, moon, stars, the Milky Way and all that is beyond, no one knows. "My thoughts are nothing like your thoughts," says the LORD. "And my ways are far beyond anything you could imagine." (Isaiah 55.8) After God created every thing there is, God created human beings, "in God's likeness" and forged with them a covenant of love. In God's likeness we might be, but God gave us the freedom to be fallible, sinful, and over and over again from time immemorial we broke the covenant of love with God, and wandered away, got lost. Over and over again God forgave us and brought us back, to the point where God came to live on earth with us in the human body of Jesus Christ. In Jesus we saw and felt God's love, mercy, and justice and we couldn't stand it, so in sin we killed him. We deserved to be abandoned by God, but God in Jesus promised never to leave us or forsake us, not even in death, so God raised Jesus from death, thus assuring us that our sins will never separate us from God's covenant of love, even in our own death. The Rev. Jeffry Reynolds Faith Journey

The character development of my faith has been dominantly influenced by geographic movements. These movements have introduced me to cultures, and fascinatingly diverse human beings, who have provided me with treasures that constantly stimulate and challenge my faith and spirit within.

I was born in the Finger Lakes region of Upstate New York on a small flower farm in Cortland. I had been baptized as a child in a small Protestant congregation, but when I was seven, my mother decided to move us into the local Roman Catholic Church. From that time until I left Upstate New York I was attending Mass, and the transformation of the Mass, created by Vatican II. Despite the move from Latin liturgies to the local tongue, the chanting, the incense, the light, and the darkness, all invited me to embrace the wonder of God's mysterious presence.

In 1980, after finishing four years of college without a degree, I decided to depart from Upstate New York by following a young Upstate woman heading to Florida. That relationship didn't last very long, but I remained in this new and different geographic location. In 1982, I met Jeanne, a native of Central Florida, who was working at the same place I was working, Walt Disney World. Our relationship grew, and in time she invited this Catholic boy to an evangelical Protestant para-church ministry called Young Life. She had been born into the Protestant world through the Presbyterian Church (USA), and in doing so she introduced me to an academic approach of understanding the Bible. The more quality you gave to biblical study, the more quality in your relationship with God. I missed an absence of God's mystery, but I also valued the sincere effort of studying the biblical text.

In time, Jeanne and I married, we left Disney for Young Life, she gave birth to our first child Casey (son), and we adopted a ten-year-old Haitian son, Berto (a faith journey story of its own, but if curious, feel free to ask when we meet). Columbia Seminary was ahead of us, but Admissions reminded me that Jeanne had received her undergrad degree, but I needed to finish my mine! The fastest way was to pack the family and go back to Ithaca College and take a full year of Religious Studies courses. These courses introduced me to world religions and the mystics of many major religions. This ten-month move back home challenged me and excited my faith significantly.

I returned South with my undergraduate degree that filled me with endless questions, but my seminary professors only cared to challenge this Catholic boy to wrestle with biblical understanding and Reformed Theology. I soon realized that this focus was critical for me if I was to engage, to care for, and to help lead Presbyterians in their faith journeys. In the end, I was grateful for the patience and the quality education I received from each seminary professor and the birth of our seminary daughter, Carlye (car-lee)!

In the years since seminary my faith has continued to be influenced by geographical movements that have challenged and expanded my faith. Living in the Appalachian culture for 28 years, travels with expatriate families throughout Saudi Arabia, visits to see students and their families in China, Taiwan, South Korea, and Japan, continued mission work in Mexico and within the Middle East in Jordan and Israel. In all these places sincere faith conversations took place. When curious I would share what this Jesus meant to me, and I was always eager to learn about the faith journey of others. Wherever I was in the world, I always found myself in a faith-filled conversation and in a position to discover new faith treasure for me to consider. I was always aware of God's mysterious presence, and God's Spirit urging me to love all neighbors anywhere from my home centered in Jesus.

#### The Rev. Jeffry Reynolds

Statement of Faith







# Statement of Activities -Expenditures

- Total 1st Quarter General Fund expenditures \$3,573 more than budget
  - Overage due solely to Closed Church Expense
    - 3 properties impacting this account
      - Waughtown property utilities
      - Stoneville property utilities & insurance
      - Covenant property (paid out grants per March EC action to 3 agencies @ \$4,314 each); utilities, insurance, lawn service
  - Quarte 1 expenditures would have been \$13,835 under budget IF there were no **Closed Church Expenses**







## Summary

### Salem Presbytery 2022 Mission Challenge Award

The income from the Mission Challenge Fund will be used by the Presbytery to encourage churches to increase their mission funding. Each year, the Presbytery shall select two churches each to receive 50% of the fund's income. The churches' use of the money will be restricted to a mission project of its choice. Those receiving the awards will be announced at a Presbytery meeting to give maximum visibility to this mission incentive program.

The first award will go to that church achieving the highest percentage increase of annual funding for the Presbytery's mission budget during the most recent fiscal year. This award goes to **Unity Presbyterian Church**.

The second award will go to that church spending the highest percentage of their annual budget on mission during the most recent fiscal year. This award goes to **Prospect Presbyterian Church**.

# **Presbytery Committee**

#### **Budget and Finance**

Reviews and advises on the financial operations of the Presbytery. Responsible for preparing and recommending the annual Presbytery budget. *Meets monthly on the third Tuesday at 9:30 a.m.* 

#### **Campus Ministry**

The Task Force is also responsible for approving and monitoring the training of CREs in the Presbytery. Meets monthly on Tuesday at 11:00 am during the week of the 4th Thursday of the month.

#### **COM Task Force on Examinations**

Meets to examine ministers and persons ready to receive a call to service and membership in Salem Presbytery. *Meets most months on the fourth Thursday at 9:30 a.m.* 

#### COM Task Force on Policy, Compensation, Mediation and Church Officer Development

Discerns best policies and practices for pastoral relationships in Salem Presbytery; this task force also provides resources for churches seeking mediation or other specific leadership needs. *Meets monthly on the fourth Wednesday at 10:00 a.m.* 

#### **COM Task Force on Temporary Ministry and Pulpit Supply**

Supports the work of ministers and churches utilizing temporary pastoral relationships, as well as maintaining the presbytery's pulpit supply list. *Meets the Tuesday before the fourth Thursday of the month at 3:00 p.m.* 

# COM Task Force on the Care of Pastors and Retirees, Members at Large/Validated Oversight and Certified Christian Educator Oversight

Provides support for members of Salem Presbytery who are honorably retired, serving in validated ministry beyond church walls, members-at-large, and our certified Christian educators. *Meets monthly on the fourth Thursday at 3:00 p.m.* 

#### **COM Task Force on Transformational Ministry for the Changing Church**

Supports and coaches churches as they discern their mission and pastoral needs. *Meets monthly on the fourth Tuesday at 1:00 p.m.* 

#### **COM Task Force on Transitions in Ministry (for Installed Positions)**

Oversees the transitional process for churches with installed pastors beginning with the moment the current pastor alerts the congregation they are leaving, through the transitional time until the new pastor is called. *Meets monthly on the fourth Thursday at 1:00 p.m.* 

#### **Committee on Preparation for Ministry**

Supports our inquirers and candidates preparing for ministry. *Meets monthly on the first Tuesday at 12:30 p.m.* 

#### **Committee on Representation**

Reviews committee vacancies, seeks candidates, confirms their willingness to serve, and presents to Presbytery for election. *Meets 2 to 3 times each quarter.* 

#### Equip

Equips congregations for ministry today by resourcing, curating, connecting and communicating. *Meets monthly on the 3rd Wednesday at 1:00 p.m.* 

#### **Executive Council**

Coordinating body of Salem Presbytery; works on behalf of the presbytery. *Meets monthly on the third Thursday at 1:00 p.m.* 

#### **Hunger Committee**

Seeks to educate, advocate, and equip non-profit agencies and churches across Salem Presbytery who are working to address food insecurity. The committee reviews international and domestic hunger grants and addresses opportunities to advocate more equitable distribution of the world's resources. *Meets quarterly*.

#### Peace & Justice Task Force

Salem Presbytery's advocacy arm, connecting congregations and individuals to the justice movements happening in the bounds of Salem and beyond. *Meets monthly on the first Tuesday at 2:30 p.m.* 

#### **Permanent Judicial Commission**

Meets when a legal case arises, only as needed.

#### **Personnel Committee**

Oversees personnel/human resource matters for the Presbytery office staff. *The Committee meets as needed.* 

#### <u>Presbyterian Youth Council – Adults</u>

Plan and implement events for Middle and High School students in the Presbytery, providing an atmosphere of fun and fellowship while sharing the Good News of the gospel, comprised of youth and adults. *Meets on 3rd Saturdays during the school year, plus events.* 

#### **Property Management Task Force**

Oversees real estate owned by Salem Presbytery, addressing any needs that arise. Meets as needed.

#### **Send Mission Committee**

Oversee the mission-related outreach and justice ministries for the Presbytery, and aids congregations in developing their own outreach and justice endeavors. Inspires and models local and global mission ministries. *Meets quarterly*.

#### **Stewardship Committee**

To build a culture of generosity through year-round stewardship efforts to support our Salem Presbytery, Synod, and General Assembly budget. *Meets monthly on the third Monday at 2:00 p.m.*
