Dear Friends:

We live in a time of exceedingly high anxiety. Climate change, the burgeoning presence of artificial intelligence, wars abroad, threats at home, mass migration, demographic changes, social value shifts, political upheaval, the rise of white Christian nationalism, and the decline of church vitality has us all on edge. As church leaders, we strive to place these sea changes in the context of our faith that though chaos may threaten, but it does not rule the day. God is sovereign and in charge.

Nevertheless, even leaders succumb to widespread anxiety, and often to their detriment. Folks in charge are supposed to address all that ails and undermines us because they have access to the resources and agency to impact our institutional well-being. When they fail to meet our expectations, we react—unfairly—against them. Acrimony focused on the leader trying to navigate us through the rocky seas is very often misplaced. Emotional energy is being foisted on the wrong party, and pastoral leaders know this all too well!

Two recent changes that our presbytery has had to face this year have been dictated by forces beyond us. The first, the upgrade of the Church Leadership Connection last year caused confusion and undue rancor as an entirely new search engine and database tailored to accommodate the myriad of inter-council permissions available under our post-nFoG polity was rolled out. Bugs needed to be worked out and there were frustrating glitches, to be sure, but technological upgrades always entail bugs and glitches. Unfortunately, CLC staff at the Office of the General Assembly were on the receiving end of a great deal of acrimony and critique for their efforts for several months after the rollout, and some that negativity continues to today. Yet I am pleased to report that several of our pastoral searches in Salem Presbytery using the new CLC system have been conducted successfully and with relatively few hiccups. The result of these searches is slated to be formally recognized at this meeting of our Presbytery.

The second, of course, has been the rollout of the Board of Pensions' benefits re-design for 2025. As has been apparent for some time from social media, few initiatives from the Board have resulted in such overt expressions of disdain and discord. Board officials have been accused of all manner of objectionable motivations as they try to keep an otherwise unsustainable benefits plan available to its members. At a recent meeting of mid council leaders in Philadelphia, Board leadership continued to be excoriated for their efforts. What few chose to recognize were the efforts of the Board to maintain and expand coverage options while at the same time seeking to control costs for congregations. Plan members and key church financial representatives are urged to register and attend one of informational gatherings on May 15 in Statesville, Greensboro, or Burlington to learn about these developments and determine with precisely how—if at all—the Board's benefits plan redesign will affect their medical coverage and church finances.

As I noted in my prior communications, our <u>real</u> concern is with the sorry state of the American health care system and detrimental policies that undergird it. It behooves us as leaders to work to make that system and all of Creation "an Exhibition of the Kingdom of Heaven" to which our Great Ends of the Church calls us to exhibit.

May it be so.

Christ is risen! Christ is risen indeed! The church calendar celebrates the Easter season as 50 days, however, in the world of transformational ministry we are always living into the promises of Easter, where hope overcomes despair and life begins

anew.



For us transformation also comes with Good Friday experiences. Another of our churches, Flat Rock Presbyterian, has voted to dissolve. It is painful to accept that any church – especially when it was the church where you grew up or were married or celebrated the baptisms of your children or your parents/grandparents built- is no longer viable. It comes with hard realities and many tears. We take some comfort in recognizing that it is also sacred ground for transformative ministry that Jesus demonstrated to us at the resurrection.

In that transformative light, Shallowford Presbyterian is looking to undertake a bold new call with a bivocational pastor. Bivocational ministry is an old thing somewhat being made new again. It was common up until the 1950s when many denominations began to prioritize seminary education. In smaller congregations it is how most of the world's Christians are experiencing church – and is projected to become the new norm. If you/your congregations have/know of folks with backgrounds in 1) entrepreneurship, 2) non-profit administration, and 3) restaurant or service station management, please reach out as soon as possible to Wes Pitts or me. This is a chance to live into our relational connectedness at its best!



And speaking of that tie which binds us as PCUSA...this past month the Kindred Sisters Cooperative Congregations ministry (Pine Ridge and Hills) ran into an unexpected and urgent need regarding a compassionate care issue in their local ministry. Two installed churches (from other parishes!) and an Engagement Pastor stepped up to assist in resolving the immediate crisis. Additionally, one of our installed church's vibrant music ministries is considering how to support churches throughout the Presbytery who are without musical or choral accompaniment. Thanks be to God!

When I meet with our uninstalled Sessions, I ask them to remember their story, who and Whose they are. This lays the foundation for inviting the Spirit into the conversation as they lean into their next chapter in God's story. The same applies for our Presbytery.

In resurrection light, may we *together* reflect on, embrace, and support each other in considering what 'transformational ministry, vital mission, and dynamic leadership' looks like for our congregations in this next chapter of our Presbytery's faith story. THE SYNOD OF THE MID-ATLANTIC

A Digest of the 253RD Assembly (PCUSA)

CELEBRATION: Hospitality reigns supreme within the Synod of the Mid-Atlantic, where every member,



from committee volunteers to commissioners, experiences the warmth of care as our defining trait. The culmination of our 253rd Assembly was marked by a poignant farewell to Tami Scott, our longstanding Administrator, as she embarks on a new chapter six months short of 11 years of dedicated service. The Administration Committee, under the leadership of TE Felicia Stewart Hoyle, orchestrated a splendid celebration featuring heartfelt video tributes from colleagues and staff from across the Mid-Atlantic region. Tami's retirement was commemorated with gifts from the Emerging Ideas

Team and Synod Staff, accompanied by tributes from the Synod Executive and the Financial Manager. Do not worry at all, Tami has helped to pick a successor. As we say farewell to Tami, we say welcome to Cameron Motley. Cameron and Tami's time overlapped for two weeks. The festivities concluded with a group lunch and a grand cake, symbolizing our fond wishes for Tami's future endeavors. Well - Done!

INSPIRED WORSHIP: Over the past five years, the Synod has embraced Matthew 25 as a guiding

principle, inspiring nine of fourteen presbyteries to adopt the vision and focus of the Presbyterian Church (USA). At the heart of the Assembly's Worship Service during the 253rd Assembly was a stirring message from the Rev. Chris Burton, Director of the Leadership Institute at Union Presbyterian Seminary. Burton illuminated the parable of the talents from Matthew 25:14-30. With a call to invest our time, talents, and resources faithfully, he urged us to embrace God's abundance and extend our impact through outreach. His sermon challenged us to move beyond mere survival and actively engage in glorifying God through our stewardship. Thank you, Chis for blessing the Assembly with such inspiration. The Synod applauds your witness to the Gospel of Jesus Christ.



CONNECTING THE DOTS: Under the adept leadership of Synod Moderator Eunil (David) Cho, the 253rd



Assembly seamlessly connected to its predecessor, the 252nd Synod Assembly, by centering both Assemblies around the theme of "Vital Black Leadership and Vital Black Churches." Presbyteries rallied their commissioners and leadership teams to actively participate, resulting in a robust turnout. The Moderator skillfully framed the continuity between the two assemblies, focusing on the past, present, and future of the Black Presbyterian Church and Black Presbyterian Leadership. The Assembly was invited to looked at the past with a rich history of Presbyterianism offered by Rev. Edward Newberry highlighting five All-Black Governing Bodies that were

dissolved resulting from the 1983 Reunion in the PCUSA. Rev. Cho asked us to look at the present and what is going on now with the Black Presbyterian Church resulting from the past assembly. Finally, he challenged us to consider and shape the future possibilities of Vital Black Presbyterian Churches by learning about the past and evaluating the present. Moderator Cho, you are a gift to AKAP, Synod and PCUSA. Thank you!

A CALL FOR REPAIR AND REPARATION: In recent discussions at the Synod of the Mid-Atlantic,



attention has laser focused towards addressing the historical consequences of the 1983 Reunion that merged two major Presbyterian denominations in America. The aim is to seek reparative measures. This segment was led by TE Jermaine Ross Allam, Director of the Center for the Repair of Historic Harms at the Presbyterian Mission Agency. Jermaine emphasized the need for acknowledgment and redress for the harms inflicted, particularly on African American communities

within the Presbyterian fold. He presented insights into the imperative of Repair and Reparation. He challenged white Presbyterians to confront the legacies of their ancestors' actions and the systemic privileges accrued through 'white-ness'. To foster deeper understanding, attendees were encouraged to watch the PBS documentary "The Cost of Inheritance/Reparations in the United States/America Reframed" prior to the assembly. During this discourse, the concept of reparations was delineated, highlighting the distinct nature of African American reparations from other global calls for repair.

Notably, two contrasting approaches were discussed: the outspoken demands of James Foreman and the strategic wisdom of Queen Mother Audley Moore. Foreman's impassioned plea, symbolized by his Black Manifesto, underscored the urgency of reparative justice, emphasizing restitution from white Christian institutions. This sentiment contrasts with Queen Mother Audley Moore's critique, cautioning against the commercialization of reparations and advocating for collective reparative action through civil rights organizations. Central to the discussion was the need to acknowledge the losses incurred during the 1983 Reunion. Works like "The Color of Compromise" by Jemar Tisby and "Dear White Christians" by Jennifer Harvey have provided crucial frameworks for grappling with racial justice and reparative measures.



The conversation extended to considering the emotional dimensions of historical trauma and healing, as experienced by different communities. This introspection prompts a critical question: how can Presbyterians foster environments that reduce trauma and enhance joy and creativity in reparative efforts? The Synod will continue to draw on this knowledge, guidance, and insights as it prepares its claim for reparative action!

UNDER CONSTRUCTION: During the 253rd Synod Assembly the critical shortage of Black clergy and the



decline of African American congregations was confronted. Synod Executive, Warren Lesane, Jr, unveiled the Next Generation Initiative (NGI) as a visionary movement aimed at reversing these concerning trends. The presentation emphasized the urgent need to engage newer, younger clergy members who are unencumbered by historical constraints, while also acknowledging the inherent cultural contexts of Black Presbyterian churches. The NGI was introduced through a captivating video, positioning it as a transformative force within the PCUSA. This initiative drew feedback from the Assembly's Stakeholders, indicating broad-based support and enthusiasm for its objectives. To provide more detailed insights, PowerPoint slides followed, outlining the NGI's

comprehensive approach across five key areas. The NGI is envisioned as a multifaceted effort to revitalize Black Presbyterian congregations and enhance the presence of Black clergy within the denomination. It will identify stakeholders, including congregations, clergy, seminaries, and supporting organizations, underscoring the collaborative nature of this endeavor. It will dive into the exploration of strategic partnerships with Historically Black Colleges and Universities (HBCUs) and other community-

based organizations which is integral to the NGI's success. The NGI will detail the long-term role of the Synod in supporting and sustaining the NGI's mission and activities. Finally, the presentation outlined the structural design of the NGI, including funding mechanisms to ensure its sustainability and impact. The Next Generation Initiative represents a bold step forward in addressing critical challenges facing Black Presbyterian communities. With its comprehensive approach and strategic vision, the NGI promises to be a beacon of hope and renewal, ensuring a vibrant future for Black clergy and congregations within the denomination.

CONVERSING STEWARDSHIP: RE Cherry Peters guided the assembly in a discussion on Stewardship.

The mandate from the 2016 General Assembly of the PCUSA was to recreate and redefine the mission of synods. Peters outlined the synod's mission and its alignment with the directives mandated by the GA Mid-Council Commission. She emphasized the synod's commitment to reimagining and tailoring its ministries to address the specific needs of its region. Peters stressed the crucial relationship between vision and mission, noting that finance naturally follows ministry. Highlighting the diverse range of innovative ministries the synod is currently undertaking, including the Matthew 25 Foci, Emerging Ideas, the Next Generation Initiative, and the Montgomery Immersion Experience, she posed a fundamental question: How can the synod sustain and expand its mission and



ministry given the limitations of the current financial model? Referring to the BOO G-3.0106, Peters underscored the significance of mission in determining the structures and forms necessary for the church's work. She quoted the section which emphasizes the unity and interdependence of the church through the funding of mission activities, cautioning against any failure to participate in stewardship that could weaken this unity.

- Providing context, Peters presented data on synod per capita rates from 2016, revealing the Synod of Mid-Atlantic's low per capita rate of \$1.15. She also noted a trend of declining church membership throughout the synod. Currently, 52% of the synod's budget is funded through per capita contributions, with the remaining 48% sourced from investment revenue.
- Looking ahead, Peters announced that the Finance Committee would propose a recommendation to the 254th Synod Assembly regarding synod per capita rates, which would impact the budgets of presbyteries in 2026.

COMMITTEE REPORTS:

- <u>Trustees:</u> The Synod as a Corporation met to ratify a line of credit with the Presbyterian Investment and Loan Programs to support the Atlantic Korean American Presbytery in meeting its financial obligations of a civil litigation.
- <u>The Emerging Ideas</u> report was shared by RE Amanda Pines who introduced the members. The committee's focus has been in their work with the Wild Church Network (a radical idea that God can occur outside of a church building). The partnership will offer a workshop on May 2, 2024, from 12 to 4 pm (via Zoom). Registration can be done via the Synod Website or by scanning a QR Code that was provided.
- <u>Finance</u>: RE Cherry Peters introduced members and provided background information concerning its sole recommendation. Checks have been delayed or even lost through the USPS, so payments being made through the Synod website's 'Donate Now' button could combat this challenge. Therefore, in the interest of efficiency and security, the



Finance Committee recommended that each of the fourteen presbyteries remit their per capita contributions and other fund payments through the Synod's online payment portal. Per capita will remain at \$1.15 for 2025. Commissioners are asked to return to their presbyteries to share

the information shared during the Conversation about Stewardship. The Assembly approved the following recommendation that synod per capita and other fund payments to the Synod be made through the Synod's online payment portal. Correspondence is forthcoming to inform each of the Synod's fourteen presbyteries.

• Administration: TE Felicia Hoyle introduced committee members and welcomed RE Miriam

Dewhurst – a former member but has now been coopted. The committee conducted a comprehensive review of Synod Policies, updating policies and guidelines as needed. Additionally, they facilitated the review of Presbytery Minutes and served as a personnel Committee, overseeing Synod Staff matters. A key focus moving forward will be the development of an Anti-Racism Policy, reflecting the committee's commitment to equity and inclusion. The committee is also in charge of the celebration for Tami Scott, Retiring Synod Administrator.



Grants: TE Tolokun Omokunde introduced committee members. More small church funding



requests than funds available were received. This may be an ongoing trend. The committee met one day prior to the Assembly to begin framing a new direction and emphasis for synod grants. The Assembly approved the following requests. **Euler and Stultz Scholarship:** Approved scholarships of \$7,000 each for Pravee Pulukuri and Spandama Valbhapuram. Approved scholarship renewals of \$3,275 each for Nenio

Pfuzeh, Geoffrey Kanyugi, and Josh Gilhart. Approved Rein Wesley for \$5,000 from the Stultz Scholarship fund. **Small Church Grants:** Approved grants of \$5,000 to Campbell Memorial (PEA), Hope PC (BAL), Iglesia Santurio (NHO), and \$3,000 to Makemie Memorial (NC). The following churches will be notified that their requests could not be approved because of lack in synod funding: Bethpage United (CHA), Danbury Presbyterian (SAL), Providence Presbyterian (JAM), and Bethlehem PC (JAM). The **Eiler Fund** is a restricted fund and has not been used in years. No applicant has met the stringent Eiler Fund criteria in twenty years. The committee asked the Assembly to direct synod staff to begin proceedings to broaden the application of the Eiler Fund.

- <u>Nomination:</u> RE Doug Sensabaugh reported efforts to fill vacancies. Correspondence was sent to presbytery stated clerks enlisting their assistance. Western North Carolina Presbytery will provide the next nominee for synod Vice Moderator. Nominations were opened from the floor.
 - o Representation vacancies- PEA and WNC
 - Jubilee Vacancies PEA and WNC
 - Nomination Vacancies PEA and WNC

<u>Executive Committee</u>: Vice Moderator Barry Parks introduced members and provided an overview of its work. The Assembly approved eight recommendations from the committee.

- 1. That the Synod of the Mid-Atlantic guarantee a line of credit up to \$80,000 from the Presbyterian Foundation for the purpose of assisting AKAP in paying legal fees.
- 2. That the Minutes of the 252nd Synod Assembly be approved.
- That the 253rd Assembly Planning Committee be empowered to make decisions on behalf of the Executive Committee related to the 253rd Synod Assembly.
- 4. That the 2024 IRS Mileage Travel Reimbursement rate of \$.67 for commissioners, committees and other authorized individuals incurring auto travel for 2024 be approved.



- 5. That TE Chip Stapleton be approved as Co-Chair of the Synod Grant Committee.
- 6. That the Synod Stated Clerk be directed to write a letter of non-compliance under the signature of the Synod Moderator and Synod Stated Clerk. This pastoral letter is notifying the presbytery of the synod's concerns of its failure to elect commissioners to synod.
- 7. That the Synod of the Mid-Atlantic's geographical boundaries overture to the 226th General Assembly be approved.
- 8. That the Synod of the Mid-Atlantic concurs with the Synod of the Northeast's overture requesting that the General Assembly create an Administrative Commission.

PRESBYTERY VOICES: This Assembly, like the past Assembly, actively engaged transformative



discussions and actions centered around the Matthew 25 initiative. Various presbyteries are demonstrating commendable commitment to addressing historical injustices and fostering meaningful change. This movement, which focuses on actively engaging in three critical areas—eradicating systemic poverty, dismantling structural racism, and nurturing congregational vitality—has gained momentum and is driving impactful initiatives across congregations and



communities. Vice Moderator Barry Parks and Past Moderator Addie Peterson addressed profound developments unfolding within the Presbyterian community. Parks shared a poignant reflection on his personal journey of discovery, revealing insights into his family history that sparked contemplation and a call to action. He bravely acknowledged the possibility of ancestral connections to slaveholders, highlighting the need to confront this historical reality with humility and accountability. Purposeful Matthew 25 initiatives are aimed at fostering justice, mercy, and reconciliation.

- <u>The Peaks Presbytery</u>, for instance, has appointed a Ministry Specialist for Justice and Mercy, demonstrating a commitment to fulfilling promises made during past assemblies. This presbytery has allocated substantial funds for anti-racism efforts and embarked on educational visits to historical sites, acknowledging and addressing its historical ties to slavery.
- Similarly, the <u>Presbytery of Baltimore</u> has made significant strides since transitioning to a Matthew 25 Presbytery. Their Dismantling Racism team has organized workshops, launched campaigns promoting civic engagement, and initiated educational activities to deepen understandings of racial injustice. Plans for further engagement, including a forthcoming Mini Summit, underscore a dedication to sustained and evolving efforts.
- Other presbyteries, like <u>Salem and Coastal Carolina</u>, have leveraged the Matthew 25 initiative to foster growth and inclusivity. Salem Presbytery convenes regular meetings to discuss the recruitment of African American pastors and strengthen partnerships within the community. Coastal Carolina has experienced notable expansion, welcoming new congregations inspired by the Matthew 25 Summit.



- The <u>Presbytery of Eastern Virginia</u> stands out for its tangible outcomes, boasting several new Matthew 25 Churches following active participation in assemblies and summits. This demonstrates the impact of collective engagement and strategic planning in nurturing congregational vitality and fostering transformative relationships.
- <u>New Castle Presbytery</u> continues to advocate for transparency and accountability, urging individuals to inquire about specific actions taken against racism.

National Capital and New Hope Presbyteries are poised to deepen collaboration and expand initiatives, highlighting the power of collective action in advancing justice and mercy. These efforts reflect a shared commitment to embodying the principles of Matthew 25 and creating communities where justice and mercy prevail.

DEEP DIVE: In the aftermath of the September 2023 assembly, participants from various presbyteries convened for a unique exploration of progress, challenges, and aspirations within their respective congregations. Led by TE Bruce Grady, Presbytery Executive of New Hope Presbytery, this introspective gathering aimed to distill the collective wisdom garnered since their last assembly, igniting discussions that delved into the heart of their communities' needs and ambitions. We are providing the following insights from this session.

Learning from the Catawba Story, the Western North Carolina Presbytery contingent embarked

- on a deep dive into the outcomes of the September assembly, drawing parallels with the experiences of the Catawba Presbytery. Insights revealed striking commonalities, particularly concerning the needs of rural churches and the critical necessity for robust pastoral leadership. This introspection highlighted the power of shared experiences and the potential for collaborative solutions.
- The James Presbytery cohort session revolved around clarifying priorities and embracing their collective narrative. Acknowledging systemic racism and the often-negative perceptions of Christians as significant hurdles, they sought to leverage their talented staff as a formidable asset in confronting these challenges head-on. Their



commitment to owning their history signifies a crucial step towards holistic growth and inclusivity.

- New Hope and Coastal Carolina Presbyteries assemblies exuded a palpable spirit of reflection and renewal, attributing the presence of the Holy Spirit to their transformative experiences in September. Their focus on engaging with the Matthew 25 initiative and nurturing trust and repair work underscores a collective commitment to meaningful action. Despite acknowledging barriers such as racism and volunteer shortages, they are poised to harness existing resources to effect tangible change.
- New Castle and Eastern Virginia Presbyteries gatherings delved into the historical narrative of their mergers, weaving a tapestry of shared identity within the presbyteries. Amidst goals of articulating their collective story and enhancing collaboration, they navigated challenges like maintaining focus and overcoming power struggles. Their emphasis on faith as a guiding force signifies resilience in the face of adversity, paving the way for collaborative progress.

Embracing Opportunities, Eastern Virginia Presbytery seized the opportunity to reframe



information and forge vital networking connections across presbyteries. Discussions surrounding the potential transition to a Matthew 25 Presbytery underscored their proactive stance in driving meaningful change. The prospect of increased engagement in Matthew 25 initiatives reflects a collective resolve to translate dialogue into impactful action.

In summary, the post-assembly reflections encapsulate a mosaic of resilience, introspection, and collective ambition within the presbyteries. As participants navigate challenges and celebrate milestones, their unwavering dedication to service and community underscores the transformative potential of collective action. These sessions not only

fostered dialogue but also sowed the seeds of collaboration, ensuring that the spirit of growth and inclusivity continues to flourish within these vibrant congregations.

STATED CLERK: Warren introduced Cameron Motley as the new Synod Administrator, succeeding Tami

Scott in her retirement. RE Tony De La Rosa was introduced as Salem's Presbytery Executive and invited to make comments. Tony has been in the field since January 2024, and we were delighted to welcome Tony to the SMA in partnership with Salem Presbytery. The Stated Clerk highlighted pastoral concerns, including unexpected deaths and the ongoing health challenges faced by commissioners. Warren stressed the importance of completing the Conflict-of-Interest Form annually. He noted his involvement in Ecumenical Ministries through the Virginia Council of Churches.

• Next Generation Initiative is a ministry in progress and is laser focused on identifying and recruiting Black Presbyterian Church Clergy Leadership and addressing the decline in Black Presbyterian Churches.



Last September, the NGI was launched. This Assembly enables all to see the components of the NGI and to understand its structure, its function and how it will relate to the Synod of the Mid-Atlantic

- Matthew 25: A first ever PCUSA Matthew 25 Summit was held in Atlanta, Georgia January 16-18, 2024. It quickly reached its maximum attendance. More than three hundred persons gathered from across the country to address Systemic Poverty, Vital Congregations and Structural Racism, and it did. Plenary presenter, Dr. William Yoo was at his absolute best as he challenged the White Presbyterians to repent for and repair the historical harms of its complicity in the United States treatment of Indigenous and people and African Americans. Dr. Liz Theoharis was in rare form in addressing the idea that Americans can end poverty. The Synod of the Mid Atlantic had the largest contingency present. Rev. Professor Mitri Raheb, Lutheran Palestinian Clergy, keynoted the Summit with riveting effect from a Palestinian perspective. Four years ago, the synod allocated \$6,940 per presbytery to assist them to engage in Matthew25 activities and to challenge their churches to do the same.
- The Clerk acknowledged that National Capital Presbytery was noncompliant because it had not elected commissioners to the Synod as required by Standing Rules.
- He discussed Permanent Judicial Commission work, emphasizing its effectiveness in handling complaints. Presbytery Leadership overview was shared.
- o TE Ann Elyse Hicks as the Presbytery Executive and Stated Clerk leads Abingdon Presbytery (ABI).
- $\circ~$ Atlantic Korean American Presbytery (AKAP), with TE Jung Sook Kim as Stated Clerk and no



Presbytery Executive, received approval for a line of credit up to \$80,000 with the PLIP.

 Baltimore Presbytery (BAL) is under the leadership of TE Jackie Taylor as General Presbyter and TE Mary Gaut as Stated Clerk, having adopted Matthew 25.

• Charlotte Presbytery (CHA), led by TE Jan Edmiston as General Presbyter and RE Tamara Williams as Stated Clerk, is convening a Black Church Consultation in April.

• Coastal Carolina (CCC), under TE Jerrod Lowrey's leadership as General Presbyter, is embarking upon strategic planning.

- Eastern Virginia Presbytery (EVA) has RE Q. John Tamm as Stated Clerk and TE Jeff Bell as a parttime Interim General Presbytery, with an ongoing search for a General Presbyter.
- James Presbytery (JAM) is led by TE Floretta Barbee Watkins as Lead Presbyter and TE Charles Grant as Acting Stated Clerk, actively engaged in reexamining its staff and funding.
- National Capital Presbytery (NAT), with TE John Molina Moore as General Presbyter and TE David Baer as Stated Clerk, is out of compliance with Synod Standing Rules.
- New Castle Presbytery (NEW) is led by TE Tracy Keenan as Missional Presbyter and Cindy Kohlmann as Connectional Presbyter.

- New Hope Presbytery (NHO), with TE Bruce Grady as Presbytery Executive and TE Ed Johnson as the temporary Stated Clerk, is participating in the Presbyterian Leader Formation, partial funded by the SMA.
- Peaks Presbytery (PEA), under TE Carl Utley's leadership as General Presbyter and TE Betsy Soto as Stated Clerk, welcomed back Soto from medical leave.
- Salem Presbytery (SAL) has RE Tony De La Rosa as the new Presbytery Executive and RE David Vaughan as Stated Clerk.
- Shenandoah Presbytery (SHE), led by TE Bronwen Boswell as Presbytery Executive and Stated Clerk. TE Nancy Meehan Yao is the Acting General Presbyter while Bronwen serves as the Interim Stated Clerk of the Presbyterian Church (USA).
- Western North Carolina Presbytery (WNC), TE Byron Wade serves as General Presbyter and TE Cameron Murchison as Stated Clerk, currently rescheduling its Black Church Summit.
- The Clerk recognized Women's History Month by honoring the leadership and accomplishments of Presbytery Leaders across the Synod. He specifically mentioned individuals such as Jung Sook Kim, Ann Elyse Hicks, and Jackie Taylor, among others, and highlighted Rev. Dr. Bronwen Boswell's role as Interim Stated Clerk of the Office of the General Assembly.

BOARD OF PENSIONS: In a recent presentation by RE Keenan Rogers and RE Elizabeth Little from the



Board of Pensions, significant updates, and changes to the benefits package for pastors were outlined. "The Season of Rebuilding" shed light on various improvements and modifications within the Board's framework, emphasizing a commitment to better serve the needs of pastors and churches.

• A notable highlight of the presentation was the introduction of a new benefits website, designed to streamline access and address previous technical issues. Keenan

and Elizabeth emphasized the importance of creating new login accounts for both benefit providers and employees to ensure a smooth transition to the updated system. They acknowledged that automatic invoice payments did not transfer over to the new platform, necessitating churches to recreate these settings.




However, it was reassuring to note that no late penalties would be imposed during this transitional period, demonstrating the Board's commitment to supporting its member churches.

- Another key aspect covered in the presentation was the provision of employer quick site guides, aimed at facilitating a better understanding of the benefits available and the processes involved. This resource underscores the Board's efforts to enhance accessibility and clarity for employers navigating the benefits landscape.
- Furthermore, a structural update within the Board of Pensions was announced to align more effectively with current needs and challenges faced by pastors and their congregations. This strategic realignment reflects a proactive approach to improving service delivery and responsiveness.
- One significant development discussed was the upcoming nationwide rollout of the Shared Ministry Program in 2025. This program facilitates collaboration between two churches to jointly employ a full-time pastor, optimizing resources and fostering community partnerships. The anticipation of this initiative reflects a forward-looking vision aimed at sustaining pastoral care and support in diverse congregational settings.

It was announced that pension checks have seen a noteworthy 4.5% increase, marking a remarkable 46% rise since 2015. This upward trend underscores the Board's commitment to ensuring financial security for pastors as they navigate their retirement planning.

Cash Bail Bond Resolution

To: The NC House of Representatives, The NC Senate and the Governor

From: First Presbyterian Church, Durham, NC

Dear Legislators and Governor Cooper,

Article XI, section 4 of the Constitution of North Carolina reads as follows:

"Welfare policy....

Beneficent provision for the poor, the unfortunate, and the orphan is one of the first duties of a civilized and a Christian state...."

However, the State of North Carolina maintains a cash bail bond system that systematically exploits "the poor, the unfortunate," in direct violation of the "first duty" as claimed in the NC Constitution.

The Constitution of the State of North Carolina continues to look to a Christian moral compass especially, but not exclusively, in regard to the treatment of the poor. In that regard, Christian Scripture clearly calls us to extend special compassion and consideration for the poor and needy.

- a. "Open your hand to the poor and needy..." (Deut. 15:11).
- b. "You shall not withhold the wages of the poor and needy laborers... You shall pay their wages daily because they are poor and their livelihood depends on them, otherwise they might cry out to the Lord against you, and you would incur guilt" (Deut. 24: 14-15).
- c. "Those who oppress the poor insult their Maker, but those who are kind to the needy honor him" (Proverbs 14:31).
- d. "The Lord enters into judgment with the elders and princes of his people. It is you who have devoured the vineyard, the spoil of the poor is in your houses" (Isaiah 3:14).
- e. Jeremiah contrasts the good King Josiah and the bad King Jehoiakim. The only criteria distinguishing them was that the poor benefited from the government of Josiah while Jehoiakim instead invested in cedar siding and gold trimming in his

luxurious house. Jeremiah declares harsh condemnation on Jehoiakim: "Are you (Jehoiakim) a king because you compete in cedar? Did not your father (Josiah) eat and drink and do justice and righteousness? Then it was well with him. He judged the cause of the poor and needy. Is not this to know me? says the Lord. But your eyes and heart are only on your dishonest gain, for shedding innocent blood, for practicing oppression and violence" (Jer. 22:15-17).

- f. Jesus implores his disciples to benefit the poor, and to never exploit them for personal gain.
- g. Jesus "unrolled the scroll and found the place that it was written, 'The Spirit of the Lord is upon me, because he has anointed me to bring good news to the poor. He has sent me to proclaim release to the captives and recovery of sight to the blind, to let the oppressed go free...'" (Luke 4: 17-19).
- h. "Blessed are you who are poor, for yours is the kingdom of God. Blessed are you who are hungry now, for you will be filled" (Luke 6:20-21).
- i. "And the king will answer them, 'Truly I tell you, just as you did it to one of the least of these who are members of my family, you did it to me" (Matthew 25:40).
- j. "We know love by this, that he laid down his life for us and we ought to lay down our lives for one another. How does God's love abide in anyone who has the world's goods and sees his brother or sister in need and yet refuses to help?" (1 John 3:17-18).
- k. "They (the apostles in Jerusalem) asked only one thing, that we remember the poor..." (Galatians 2:10).
- "But you have dishonored the poor. Is it not the rich who oppress you? Is it not they who drag you to court?" (James 2:6).

Fidelity to the NC Constitution then requires changes to the current cash bail system which exploits the poor. Considerable empirical evidence demonstrates that the cash bail system is inequitable and ineffective. The cash bail system requires pretrial defendants to pay hundreds to thousands of dollars to keep from going to jail. Because of economic challenges, a significant portion of these arrestees lack the 10%-15% non-refundable premium a bail agent charges, so they end up spending weeks and months in jail awaiting trial. Courts, often secured through bail bondsmen, typically result in low-income individuals agreeing to usurious borrowing terms to obtain funds. Several municipalities and states throughout the United States, and a few places in North Carolina, have successfully enacted other approaches to pretrial requirements for defendants accused of misdemeanors and some nonviolent felonies.

Additionally, the current bail bond system is more expensive financially to the State than the proposed changes offered by the NC House Bill 271. Enacting NC House Bill 271 will save the state money.

Multiple studies, including the work of Jessica Smith, W.R. Kenyan, Jr. Distinguished Professor of Public Law and Government at UNC School of Government, report the need for change based on four problems with the current system: public safety (wealthier individuals can buy their way out of incarceration); costs to taxpayers; fairness; and racial and ethnic disparities.

WHEREAS, the vast majority of the jail population increase since 2000 was caused by the detention of individuals prior to trial (pretrial) of which 60% to 70% were classified nonviolent minimum-security;

WHEREAS, the Class Three misdemeanor cases addressed in NC House Bill 271 do not constitute a risk of flight;

WHEREAS, at least 70% of people held in local jails are not convicted of any crime;

WHEREAS, the inability to make cash bail extracts an untold human cost on the accused due to their loss of employment, housing and, often times, family support;

WHEREAS, there are proven instances of inadequate health care for incarcerated persons, death and injury suffered by incarcerated persons;

WHEREAS, bail set for people of color exceeds that for whites by 35%;

WHEREAS, three out of four criminal cases in state trial courts are for misdemeanors that, if proved, would result in fines and/or less than a year in jail;

NOW THEREFORE BE IT RESOLVED, the Session of First Presbyterian Church of Durham, NC petitions the NC legislature to pass NC House Bill 271. Additionally, the First Presbyterian Church petitions the Presbytery of New Hope to endorse the passage of NC House Bill 271. The Session encourages the Presbytery to encourage each church session in the Presbytery of New Hope to adopt this resolution and to contact their state representatives and Senators. Furthermore, that the Stated Clerk of the Presbytery convey this stand to every NC Representative, Senator, and the Governor. The Stated Clerk is directed to communicate this resolution to the Presbyteries of Western North Carolina, Coastal Carolina, Salem, and Charlotte for consideration and adoption.

The Executive Council (EC) met on March 21, and April 18, 2024.

Regular reports were received from Tony De La Rosa (Executive Presbyter), Jodi Lingan (Designated Presbyter), and David Vaughan (Stated Clerk).

For Information – The Executive Council:

Acting on behalf of Presbytery:

- Elected the Church Growth and Transformation to serve as the Session for El Buen Pastor New Church Development;
- Approved a request for Vandalia PC to sell its property;
- Approved a request for Cleveland PC to sell a small building that is not contiguous to the church property;
- Dissolved the Oakview PC in Caswell County; Salem Presbytery and Oakview have not had a relationship whatsoever since the mid-1980s (our attempts have been refused), and there is no Presbyterian remnant in that church;
- Elected the following as PC(USA) Examination readers: RE Melanie Adams, RE Austin Campbell, TE Kathryn Campbell, TE Kim Priddy, RE Sandi Rice, TE Liz Troyer;
- Concurred with three overtures to the General Assembly; the date for registering concurrence was before Presbytery's May 2024 meeting, and this action only ensures that the appropriate committee will hear the overtures:

*Overture 026 (realigning Self Development of People with its historical purpose); *Overture 011 (appointing a committee to review the Preparation for Ministry process);

*An Overture that would constitutionally allow for "virtual communion" because the current advisory opinion made by former Stated Clerk J. Herbert Nelson has expired. The Advisory Committee on the Constitution has determined that an overture is not necessary for this matter. This issue will be considered at GA226 as an authoritative interpretation of the Directory for Worship.

Business of the Executive Council:

- Approved the docket for the May 2024 meeting of Presbytery;
- Received regular, detailed financial reports from the Budget and Finance Committee;
- Approved minutes of previous meetings of the EC and of the Presbytery;
- Added Tony De La Rosa as a signatory on Presbytery accounts, replacing Jeff Sockwell who has moved; there is a precedent for the Presbytery executive to be a signatory in Salem;

Recommendation

On realigning Self Development of People (SDOP) with its historical purpose

The Pacific Presbytery overtures the 226th General Assembly (2024) to realign Self Development of People (SDOP) with its historical purpose, emphasizing self-determination for the African American community and the original focus of addressing the residual impact of slavery and oppression by:

1. Requiring that SDOP abides by the Articles of Agreement of 1983, reaffirming the PCUSA's commitment to equity and justice, and

2. Directing SDOP to allocate an initial \$5,000,000 to put in place infrastructure and resourcing, followed by a recurring \$1,000,000 investment annually for 25 years, to aid African-American congregations in enhancing their community involvement, advocacy, and witness for Jesus Christ's love and justice.

Rationale

Rationale

The Presbytery of the Pacific presents this overture to the 226th General Assembly, to align the General Assembly (GA) and the PC(USA) Self Development of People (SDOP) with the core values of our denomination to dismantle structural racism as a witness to the Gospel of Jesus Christ and the PC(USA) Matthew 25 movement.

This proposal centers on returning SDOP to its original mission, which was established in response to Rev. James Forman's call for reparations, with a specific focus on compensating, empowering, and developing the African American community. We aim to uphold the Articles of Agreement of 1983 and fulfill the PC(USA)'s commitment to "equity, justice, and correcting past patterns of discrimination," defined here as reparations within the African American community and its associated constituents.

Our motivations are deeply rooted in addressing the underachievement of SDOP's mission related to systemic racism and poverty in the African American community. The Pacific Presbytery aligns with commissioners and delegates who approved the RGJ-08 Overture during GA 225, directing the PC(USA) to commit to restorative justice and reparations, to close disparities in economics, health, education, environmental well-being, and the criminal justice system caused by the legacy of slavery and white supremacy. While we believe SDOP has been limited in its ability to focus on the prophetic call for reparations within the African American community, we do affirm that it has been a valuable resource in addressing poverty and the needs of other communities.

Regarding SDOP, established in 1970 as the form of reparations from the PC(USA) (formerly known as the UPCUSA), which has historically benefited from slavery and racist policies, it has deviated from its original mission. The current SDOP focus no longer aligns with the needs of African American congregations and their communities. Reparations should not be sought only from SDOP but from a broader reservoir within the Presbyterian Church (U.S.A.).

A persistent and unresolved challenge has continued to exist between the mission of SDOP and African American congregations and their constituent communities. African American congregations have refrained from applying for SDOP grants because of their classification as religious institutions. Ironically, those who originally conceived the SDOP concept did so to address the economic and social challenges within communities that now require these resources the most. These African American congregations are firmly committed to serving the impoverished, marginalized, and oppressed in our society. They embody the principles of self-determination and exemplify a community dedicated to self-help. African American congregations extend their services to individuals within their congregations and communities who are in need.

This overture seeks to realign SDOP with its original purpose, ensuring it actively contributes to reparations and empowers the African American community within the PC(USA). By refocusing SDOP, we aim to address historical injustices, empower the African American community, and strengthen the PC(USA)'s commitment to equity and justice. We pray that these actions will promote a more just and equitable future for our denomination.

Recommendation

On Appointing a Committee to Review the Preparation for Ministry Process

The Presbytery of the Highlands overtures the 226th General Assembly (2024) to appoint a committee to review the overall Preparation for Ministry process, and to make recommendations for relevant and appropriate changes to the 227th General Assembly (2026).

The Committee will be responsible for the following:

- An overall review of the Preparation for Ministry process including an assessment, evaluation, and recommendations for changes to the Presbyteries' Cooperative Committee on Examinations for Candidates (PCCEC):
 - \circ revision of the handbook, including the process
 - \circ development of ordination exams
 - \circ selection/nomination of the team responsible for overseeing exam writers.

• Make recommendations for next steps to bring the process in line with today's church and its needs, or to develop a new process.

• The committee shall consult with presbytery leaders and committee on preparation for ministry (CPM) moderators concerning the process including a discussion on their understanding and suggestions concerning G-2.0607d: "examination materials, together with evaluations that declare those materials satisfactory in the areas covered by any standard ordination examination approved by the General Assembly. Such examinations shall be prepared and administered by a body created by the presbyteries."

• The committee shall consult with the Unification Commission on issues and concerns about the Preparation for Ministry process.

• The committee shall consider the following questions in their report to the 226th General Assembly:

 Are ordination exams still necessary in the church today? Are the process and exams as they are now meeting the moment of the church and culture? Do they perpetuate white privilege culture and values?

• Is the process helpful to form people who will be operating within this white privilege culture church or is the process missing the point at which the church is trying to move beyond?

• What are ordination exams looking for and are they the best way to find it? What is being examined that isn't already discovered through the CPM process and the requirement of a seminary education?

 If the exams are still necessary, how might they examine what needs to be understood in the multicultural, racial, and power-imbalanced twenty-first century? Are these exams still serving their greater intended purpose?

• How can readers come to the process without their cultural bias and perhaps "old school⁴View of the church, and provide an objective and impartial standard to test taker responses that may not reflect the reader's cultural understanding? How does having evaluators who don't know the test takers or anything about them improve the preparation for the ministry process?

 $\circ\,$ How do we improve the integrity and relevance of preparing people for ministry to benefit the church and culture in the post-pandemic world?

• The General Assembly moderator(s) appoint a team of twelve which will include at least four mid council leaders and two CPM moderators. The moderators should also consider for the committee recently ordained clergy, ruling elders, men and women, and a diversity of ages, cultures, racial and gender identity. The team should be staffed and receive support from the Office for Ordered Ministry and Certification, The Office of Racial Equity and Women's Intercultural Ministries, The Office of Theological Education.

Rationale

Rationale

In early 2023 the Exegesis examination, developed by the Presbyteries' Cooperative Committee on Examinations for Candidates (PCCEC) focused on Judges 19, which includes the rape and dismemberment of a concubine. Many test takers, mid council leaders, CPM moderators and others have pushed back that this was an inappropriate passage to use for students to demonstrate their ability to exegete a passage. Many test takers and exam readers found this text hard to read, let alone useful for formulating a curriculum for college students; some acknowledged that it triggered trauma responses. The response of the PCCEC to the concerns expressed by mid council and CPM leaders was slow.

In the weeks and months following, The PCCEC slowly shared information on how they determined that this was an appropriate passage to use. What we learned from those exchanges and conversations is that the process for developing the examinations works on a three-year cycle. Within that cycle anyone on the PCCEC can flag exam passages, questions, or scriptures as inappropriate or in need of revision or editing. This particular passage did raise flags but remained in the process. We also learned that the PCCEC process does not include any input from other OGA/PMA staff, other diverse voices, or feedback from outside the committee (even those bodies created expressly for that purpose), thus forming a closed loop of conversation and information. The PCCEC's funding model, unusual for the Presbyterian Church (U.S.A.), was cited as a hindrance to a more open system.

The process for ongoing conversation about examining seminarians failed both the students and the presbyteries the PCCEC is meant to serve. A story about the rape, abuse, and dismemberment of a woman was not appropriate for exegesis by candidates for ministry. Even well-seasoned pastors would approach this conversation with caution, if at all.

The test takers were told they could not consult or speak to anyone about the test while they were taking it. Many students became upset with the material but felt that they couldn't speak with anyone for fear it would cause them to fail the exam. The ordination exam is already stressful, and being faced with questions that cause trauma and not being able to discuss this with anyone is unconscionable. The exam instructions were

silent on how to seek help if this passage triggered a trauma response or traumatized the exam taker. A fecent pilot project initiated by the PCCEC seeks to remedy concerns about seeking support and counseling during the exam, but this was no doubt instigated by the volume of comments that came from outside the closed loop.

When the mid councils and CPM leaders sought explanations about the exam the response from the OGA and the PCCEC was inadequate, very slow, frustrating, and confusing.

What was learned from this experience is that the PCCEC and the ordination exam process no longer functions as a confidential process but as a secretive process. The ability to appropriately and nimbly respond to concerns is inadequate and confusing. Concerns raised even within the committee went unheeded. The whole process, including the structure and funding of the PCCEC, hasn't been thoroughly examined in a very long time. The Book of Order reference (G-2.0607d) that the process is developed by the presbyteries no longer applies.

The conversation concerning ordination exams this last year also prompted other conversations and questions concerning exams and the process of ordination:

• Are the exams still necessary and if so, how can they examine what needs to be examined in a multiracial, multicultural, power-imbalanced twenty-first century?

• Are the exams and the process in the present form meeting the moment of the church and culture? Or are they perpetuating a white privilege culture and values beyond their reasonable life in the church?

- Is the process as a whole helpful to form people who will be operating within this white privilege culture church or are they missing the point at which the church is trying to move beyond?
- Is the present process and ordination examinations out of touch with the reality of church life, culture, and ministry?

These events and conversations have led to the overture asking for a full review of the process in light of the church today.

SALEM PRESBYTERY Retirement The Rev. Kellie JoAnne Browne

Kellie Browne's journey to Ministry of Word and Sacrament in the PCUSA followed some roads less traveled. Born in Toronto, Kellie has described her family of origin as "nominally Anglican." After marrying in the United Church of Canada and starting a family, she and her husband Richard moved to Maryland. New neighbors invited them to a Presbyterian Church (U.S.A.) Kelly felt that God had been waiting for her there. She became actively involved in church, was ordained deacon and elder, and worked in three different congregations as the family relocated. In North Carolina, her family began to worship at Oak Ridge Presbyterian Church. At age 40 Kellie felt called to Ministry of Word and Sacrament and began working on her B.A. in history at Guilford College. Upon graduation, she enrolled at Wake Forest School of Divinity.

After completing her M.Div. degree and having been recommended as a dedicated and organized mid-life minister, in 2010 Kellie accepted a call to John Calvin Presbyterian Church in Salisbury, the "small church with a large heart." Being a solo pastor, she performed a variety of tasks-- planning worship and preaching weekly, along with administration and pastoral care. As is typical of pastors serving aging congregations, Kellie conducted many funeral services at John Calvin. She is known for making each one exceptionally personal and appropriate. Kelly is also remembered for sharing her artistic talents with the congregation.

Kellie's administrative skills have benefited the larger church as well as John Calvin PC. She served as co-moderator of Salem Presbytery's Commission on Ministry. In that capacity she worked with other Salem congregations and pastors. As a member of the Executive Committee of the American Waldensian Society, she was instrumental in planning a trip to study immigration with faculty of the Waldensian Seminary in Rome in 2013. Several pastors and two executives from Salem Presbytery participated in that trip. In Salisbury, Kellie volunteered with Rowan Hospice and Palliative Care. Currently she serves on the Wake Forest University School of Divinity Board of Visitors.

Kellie has been a ready listener and supportive friend to her colleagues in ministry, always willing to share the trials that ministry inevitably brings. While serving John Calvin PC, Kellie regularly participated in the Rowan Presbyterian pastors' monthly luncheons. She initiated and coordinated bi-weekly gatherings of local clergy women of various denominations for coffee and conversation. At one of these gatherings Kellie learned that the Piedmont Unitarian Universalist Church had outgrown the space they rented from Temple Israel which, at the time, was next door to John Calvin PC. In keeping with John Calvin's emphasis on outreach and interfaith alliances, Kellie facilitated getting permission for PUUC to use John Calvin's outbuilding (AKA "the hut") for their children's religious education.

In 2016 Kellie resigned from her position at John Calvin. Soon thereafter she moved with her husband to Winston-Salem and now spends most of her time being Nana. However, she has continued to be active in the presbytery as a minister-at-large, attending Trinity PC in Winston-Salem where she assists with worship and other activities as needed. No doubt she will continue to fulfill her calling to serve Christ and his church under the new status of "retired."

On the occasion of her retirement from the Salem Presbytery, we celebrate and give thanks for the ministry of the Rev. Dr. Jill Y. Crainshaw. Jill will continue her role in the School of Divinity at Wake Forest University.

As Jill's colleague at both Wake Forest School of Divinity and the Salem Presbytery, I have had the privilege of witnessing her profound impact on our community firsthand. Jill has brought her delightful and surprising curiosity and creativity, a depth of theological understanding, a profound commitment to social justice, a passion for integrating worship leadership, liturgical theology, and spirituality, and a dedication to the integrity and ethical standards of our ministry to enhance clergy education, spiritual formation, and the Presbytery's ministry to its congregations.

A distinguished theologian and liturgical scholar, Jill serves in validated ministry as a Professor of Worship and Liturgical Theology and Vice Dean for Faculty Development at Wake Forest University School of Divinity. She obtained her Bachelor of Arts from Wake Forest University and a Master of Divinity from Southeastern Baptist Theological Seminary. She was first ordained in the Baptist tradition and later received as a member of the Presbytery of Shenandoah. In 1987, having earned the MDiv degree, Jill was called to be the first woman pastor of Neriah Baptist Church in Buena Vista, VA, where she served for six years; at the same time, she was chaplain for the Hospice of the Rapidan for two years. Jill also served as a pastoral care consultant at Buena Vista Presbyterian Church in Buena Vista and assistant chaplain at Sunnyside Presbyterian Retirement Community in Harrisonburg, VA. Jill earned her doctorate at Union Presbyterian Seminary in Richmond in 1998.

In 1999, Jill was called to the Wake Forest School of Divinity as its first Director of Vocational Development and Continuing Education. In her faculty role at the School, Jill has taught various courses in preaching and worship leadership that explore creative and contextually relevant approaches to worship throughout the liturgical year. She has developed and offered courses in ministerial ethics; food, health, and ecological well-being; and Christian spirituality, among many others. For many years, Jill served as the Associate Dean of Academic Affairs and later as Acting and Interim Dean of the School of Divinity. Jill also led the School's worship leadership team, which designs the School's weekly student-led community worship services.

Jill has shared her considerable gifts to advance the work of our Presbytery. She has served in various roles on the Salem Presbytery's COM, including as a member of the Salem-First Presbyterian Conciliation Team; as the Presbytery's representative to the North Carolina Council of Churches; as the Presbytery's liaison to various congregations in pastor search processes; and on many administrative commissions for the ordination of Wake Divinity students and others. She has provided many workshops and consultations to Salem Presbytery ministers at various stages of their careers and interim ministry to Salem congregations, including Clemmons and Trinity Presbyterian Churches. For many years, Jill proctored the PC(USA) ordination exams at Wake Forest School of Divinity. Crucially, Jill led the Presbytery's efforts to improve clergy well-being, developing and leading trainings for Salem leaders on strengthening professional boundaries.

Jill has been a wise and generous mentor to me and many of our colleagues. As my predecessor in theological field education at Wake Forest, Jill has graciously created spaces for sharing her wisdom

and exploring our shared experiences as teachers, administrators, and pastors. I am deeply grateful for her collegiality, mentorship, and friendship.

When Jill transferred to the Salem Presbytery in 1999, she wrote: "In a time when many have concluded that the church is a crumbling institution, I am committed to re-capturing the church's vision of a world redeemed by participating in the renewal of its communal life. I am dedicated to the continued transformative potential of the Church to mediate to the world the love and grace of Christ." Jill's work in the School of Divinity and the Salem Presbytery has amply demonstrated this commitment, for which the church is deeply grateful.

In addition, Ernie contributed to the larger church by serving on the Board of Trustees of Union Presbyterian Seminary and as a board member and President of the Coastal Carolina's Presbyterian Counseling Center.

Ernie is a committed friend to other ministers, many of whom were members of his annual Great Preaching Seminar and Theology Reading Group. He enjoys a competitive game of golf with his weekly "Covenant Group," and greatly enjoys the 19th hole rewards of winning. Executive Council

Coordinating body of Salem Presbytery; works on behalf of the presbytery. *Meets monthly on the third Thursday at 1:00 p.m.*

Hunger Committee

Seeks to educate, advocate, and equip non-profit agencies and churches across Salem Presbytery who are working to address food insecurity. The committee reviews international and domestic hunger grants and addresses opportunities to advocate more equitable distribution of the world's resources. *Meets quarterly.*
