Transitional General Presbyter

Final Report of the Transitional General Presbyter to Salem Presbytery September 9, 2023

As I sat to prepare my final report as your Transitional General Presbyter, I went back and looked at the 11 reports I presented to Presbytery, as well as my nearly monthly reports to Executive Council. That exercise really helped me to help all of us to remember the work we've done together as I transition into retirement as of November 1, and as you make the transition to an installed General Presbyter on a timeline yet to be determined.

For the November 10, 2020 stated meeting – 10 days into my tenure with you – I shared with you my prayer for our time together. I wrote, "That when the time comes for me to depart, you will say 'gosh that was hard work but I'm glad we did it'...and with God's guidance, and God's grace, we will look at these days somewhere down the road, through the rear-view mirror, ultimately stronger for the lessons learned and bridges built."

We definitely weathered some storms together in year 1.

I walked into a storm of hurt feelings, resentment, woundedness, and anger. There was a lack of trust, a perceived lack of transparency, and a lack of accountability. There were factions. As I pointed out to the Executive Council and to the presbytery as a whole, there were elephants in the room. The only way to deal with the elephants was head on and the only way to get them gone was to name them.

To that end:

At the May 2021 presbytery meeting, we engaged in a litany to recognize the dissolution of the Implementation Team that had been formed to carry out the work of the Dream Team. The presbytery said thank you, we asked for forgiveness for the times that the waters were not always calm, and we acknowledged the time and prayer as well as the joy and pain experienced. We heard from the Implementation Team accepting the presbytery's gratitude, the granting of forgiveness and seeking forgiveness for their failures, and turning those things undone back to the presbytery. In the words of Polly Pruitt, a member of the Implementation Team, "We ended up in a deep well which is slowly filling with life-giving water that will sustain as we move forward in our new vision for Salem Presbytery."

Executive Council officially named the elephants at the August 2021 presbytery meeting, and at the November 2021 presbytery meeting, we included your additions. During our worship we asked for and granted forgiveness. And we also identified for ourselves a past or present hurt or grievance that we were willing to set aside for the health of the presbytery going forward.

I also walked into the storm called COVID that had been raging for 8 months when I began working with you. Including a variety of voices from the geographical diversity of the

presbytery, a COVID response team was formed. At least six letters to the presbytery were prepared as the highs and lows, and the peaks and valleys of a global pandemic had their way with the world, the United States, and North Carolina in particular. The response team made suggestions and recommendations based on available data and CDC counsel. Three and a half years later, COVID is still alive and well, albeit on a smaller scale as we do our best with vaccinations, masks and Paxlovid!

In year 1, Zoom became a verb. It was what we did, it was how we connected. It was our new norm. We had a Mingling Dinner Party gathering at Christimas time, and for a while we had an "It's 5 o'clock somewhere" gathering. All committees, commissions and task forces continued to meet without missing a beat. Many churches – who hadn't already - learned how to utilize the gift of technology and live-stream.

Year 1 wasn't all about storms, however. There was a lot of other important work happening too.

The Commission on Ministry underwent a thorough restructuring process. Whereas there used to be 3 neighborhoods – east, central and west - who oversaw everything in those areas, the move was made to seven task forces with specific duties for the entire presbytery. After some time with seven task forces, we realized two of them could be combined to be more effective. No more overlap of responsibilities.

One carry over from the Dream Team plan was the idea of Engagement Pastors. In early 2001, five parishes were identified and smaller clusters formed. In the Spring of 2001, five Engagement Pastors were hired and their new work of connecting people and churches in Salem Presbytery began. With two personnel changes along the way, those Engagement Pastors continue their important work.

Finances – In 2021, we became aware of the fact that the Synod of the Mid Atlantic – in 2018 - was promised payment of \$17,040.98 in outstanding per capita. Executive Council authorized me to write a letter to the Synod asking for forgiveness of past indebtedness with a promise to pay 100% of our per capita assessment going forward. The indebtedness was forgiven, and we have kept our promise to the Synod. We have also been remitting increasing percentages of assessed per capita to the General Assembly.

In November of 2021, my report to presbytery had this to say: "It seems hard to believe that I have already completed one year as your Transitional General Presbyter. And it is a year in which we have all worked hard together. As we move into our second year together, I've laid out some "wonderings" for Executive Council for my next two years with you. Year 2 will have us looking at Salem's (1) mission and vision statements to begin to keep them out in front of the Presbytery so that all decisions/plans/financial commitments that are made intentionally fit within the presbytery's mission and vision; (2) committee/commission structure to be sure we are "putting our money where our mouth is" – i.e. are we supporting what we say is important to our mission and vision; and (3) With #1 and #2 in mind, and with committees/commissions taking greater ownership rather than being staff driven, together with a realistic view of the Presbytery finances and a sense of what should be done with invested monies, determine what staffing structure should look like after year 3. Year 3 will have us living to our mission and vision with greater committee/commission ownership as the presbytery searches for installed leadership."

In 2022 ...

After work in 2020, and a major push in 2021, the Budget and Finance Committee and Executive Council were given a full, detailed report on the presbytery's designated and restricted funds. Each one was individually considered and some changes – where allowed – were made. That report was made fully available to the presbytery.

A Gift Acceptance Policy and an Investment Policy were both adopted in 2022.

Executive Council recommended, and Presbytery approved forming the position of Designated Presbyter for Transformational Ministry. After interviews with several applicants, Rev. Jodi Lingan was hired for a period to run concurrently with my contract to specifically work with the congregations of Salem Presbytery served by a Stated Supply, Temporary Supply, CRE, or pulpit supply – a full half of the number of our churches. You took a leap of faith to create that position and I can't say enough good about the work Jodi is doing.

In May of 2022, Executive Council had a zoom retreat to focus on future staffing for the presbytery. We began with reflection on Isaiah 43:15-21, with specific focus on verses 18 and 19 – "Do not remember the former things, or consider the things of old. I am about to do a new thing; now it springs forth, do you not perceive it? I will make a way in the wilderness and rivers in the desert." I posed questions for discussion, including: what do you believe the new thing is that God wants us to do; what new questions do we need to ask; given the presbytery's mission and vision, what is essential to our identity; and how is this different from March 2020. (A staffing plan was created, and as you will see reported below, approved!)

Some of the comments that emerged from our discussion were the acknowledgement that we've made great strides in changing the culture of the presbytery but it's a work in progress; creating the position of Designated Presbytery for Transformational Ministry has been very significant; as Christians and members of Salem Presbytery, we have the responsibility to speak up and speak out on societal issues; relationships matter; the importance of Engagement Pastors; and to be connectional, catalysts and proclaimers.

Church Growth and Transformation introduced the Seven Marks of Vital Congregations, an initiative of the Presbyterian Mission Agency. One of those seven marks has been presented as part of every presbytery meeting since then, culminating in the final mark being presented at this meeting. Church Growth and Transformation also purchased a subscription for the demographic tool, Mission Insite, for 2022 and 2023. It has been decided not to continue that subscription in 2024.

Personnel concluded their important work on an up-to-date Personnel Manual.

In November of 2022, my report to presbytery had this to say: "Two weeks ago, on November 1, I began my third and final year with you as your Transitional <u>General Presbyter</u>. And today marks the next step – a very important step - on your journey toward installed leadership!

"In my last report to the Presbytery's September 2022 meeting, I shared that future staffing conversations had been, and would be, happening with Budget and Finance, Personnel, and Executive Council. Long, in depth, discerning conversations have indeed taken place. And today,

marks the next step – a very important step - on your journey toward installed leadership as that plan is before you – the body of Salem Presbytery – for conversation and vote!"

And vote you did! You approved the staffing plan which would include a full time Administrative Assistant, part-time Financial Secretary, part-time Communications Director, part-time Stated Clerk, full-time Designated Presbyter (until at least 2025), and full-time General Presbyter. In addition, the Five Engagement Pastors would continue on a contract basis.

In 2023, a policy was adopted on the use of funds from closed churches. And, to that end, Church Growth and Transformation has been working on a grant process with funds already in their purview, as well as new funds from closed churches. You will hear more at this meeting.

Not confined to a particular year but important ...

The Stewardship Committee jumped into high gear. They met with Olanda Carr, our representative from the Presbyterian Foundation to talk about the nature and practice of stewardship, as well as how to further our initiative in Salem Presbytery. Through the one-on-one connections of the stewardship team with pastors, leaders, and churches in Salem Presbytery via phone and note writing, the number of church support pledges and the amount of those pledges have increased.

EQUIP began sharing resources with the presbytery and would begin planning educational opportunities for after presbytery meetings. In 2023, they held Elder training workshops in each parish, and are planning similar training in 2024.

Committee on Preparation for Ministry continued their important work with Inquirers and Candidates. It is always a thrill to move someone to the status of "Certified Ready to Receive a Call" and see where God's call leads them.

Campus Ministry – Executive Council empowered a task force to work on a plan to implement the Dream Team's recommendations on funding campus ministry. That task force has continued to work and a new campus ministry manual and funding model have been created and approved.

The Hunger Committee meets twice a year to consider applications for funds collected with all of your collected pennies. Grants are made both domestically and internationally. The Peace and Justice task force meets monthly and has been responsible for putting into place our Racial Equity Training.


I have said it before and will say it again. Salem Presbytery has a staff of whom you can be proud. They work amazingly well as a team and are dedicated to the work to which God has called them! We have met nearly weekly on Monday mornings.

In closing, I would like to express my heartfelt thanks to all of you – Salem Presbytery – for the privilege of serving you these past three years. My prayer is that you can honestly say "'gosh that was hard work but I'm glad we did it'...and with God's guidance, and God's grace, we will look at these days somewhere down the road, through the rear-view mirror, ultimately stronger for the lessons learned and bridges built."

Designated Presbyter



My reports to date have centered on the sobering, hard realities facing our churches. Since we were together last, another church has requested dissolution with two additional churches standing on the brink. Three churches are moving from installed to uninstalled. I've used numbers over the past year to help us articulate our

from installed to uninstalled. I've used numbers over the past year to help us articulate our reality. This has been painful, but ignoring or glossing over them is spiritually irresponsible.

As God's children, however, this Presbytery is embracing that we are **resurrection people**, we are the ones blessed to here in this piece of the Kingdom, to lead our churches *now* in letting go of whatever does not enable us to proactively enable spiritual growth and service as the hands and feet of Jesus Christ in the world.. I would like to share some of the "**lights**" **shining under the bushels** in Salem Presbytery:

- **Four Shepherding Teams** have been engaged: one resulting in a Stated Supply call, one in potential dissolution, two teams are still underway.
- We are introducing a **new ministry model ("Cooperative Congregations")** this September in Parish E.
- We are participating in the Wesley Theological Seminary **Religious Workforce Project**: a national study on today's changing religious landscape, how leaders of congregations are adapting, how these changes shape staffing, financial models.
- We are exploring three new **community building initiatives**:
 - Rural NC (https://www.ncruralcenter.org/engagement/faith-in-rural-communities/): creating socially dynamic and economically vibrant rural faith communities across N.C.
 - Wesley Community Development Corporation (https://wesleycdc.com): an innovative, full-service, non-profit real estate firm partnering with faith-based organizations in helping them reimagine, repurpose, and redevelop their physical assets.
 - Sympara (https://www.sympara.org): their mission is to "help communities repurpose underutilized religious properties for social impact.
- We are sending a team on September 10-13th to the Synod focused on the state of African American Congregations Pastoral Leadership within the region and the nation.

I often hear of how our churches are struggling in their own individual wildernesses. We proclaim to be the **relational**, **connectional denomination**. It is biblical and radical - just like Jesus was (and still is). Yet how we put this into practice is elusive. In this season of Ordinary Time, of what it means to focus on maturing and growing as disciples of Jesus Christ, I encourage you to **ask your Sessions to spend five minutes discussing** what it means to be Church in your piece of the Kingdom...and listen carefully to the answers. And then make it a

priority for you or your elders to worship at another church in your parish – just once - before the next Presbytery meeting so that *together* we will serve more authentically to the glory of God. The disciples didn't choose each other; they were chosen by Jesus. One body – because of Jesus Christ.

As a note of personal privilege, I wish to express my **profound gratitude** for the support and encouragement of our Interim Presbyter. Plain and simple, without Barbara's insight, none of these efforts would have seen the light of day. Transformation, however you may define it, is a living, breathing, evolving reality in Salem Presbytery - thank you Barbara!

I leave you with this **poem by Rev. Sarah Are.** It is a wonderful means for thinking about how we approach new ways of defining relational, connected, togetherness in Salem Presbytery. I have no idea what comes next; however, **I am grateful to be on this adventure with you – that we may learn anew to share our flashlights!**

A LITANY OF REPENTANCE

As white Christians, we repent of our complicity in the belief in white supremacy: the belief that people of European descent are superior in intelligence, skills, imagination, and perseverance. We acknowledge that this belief in white supremacy has been the foundation of, and an excuse for, atrocities against people of African descent in the United States and in the world.

We repent of our failure to recognize and take responsibility for the legacy of slavery.

We repent of the injustice, pain, humiliation, and suffering imposed on African Americans by our ancestors and ourselves through actions and inaction. We repent of our complicity in failing to act in mutual loving relationship.

We repent of closing our eyes to the degradation and injustice forced upon African Americans who were enslaved, segregated, terrorized, and imprisoned.

We repent of covering our ears to the crying of families torn apart, to the sound of human flesh being struck, while songs of freedom and heavenly grace flow from our lips.

We repent that we have failed as an institution and as individuals to use our voices to abhor and end lynching, segregation, and racial profiling. We regret our generations of silence on these issues so that we could maintain a comfortable life in our churches, homes, and communities.

We repent of shutting our hearts to the experiences of fellow humans whose stories of pain, suffering, hardship, struggle, love, and joy mirror our own life journeys, yet are deprived of privilege and marred by racism. We have turned our backs and walked away pretending not to see, yet we saw, pretending not to know, yet we knew, and convincing ourselves that we were not complicit, yet we are.

We now know that we as white Christians have benefitted directly and indirectly from these injustices. We name ourselves as complicit and repent.

Finally, we repent of our violent actions to suppress Black agency. African Americans, since the time of slavery, have actively pursued their freedom ... built this country ... laid foundational structures ... and demonstrated their capacity to fully participate in the construction of this American society in spite of white supremacy.

As repentance means turning and going the other way, with Christ's help we seek to do so. At the same time, we commit ourselves to walking with people of African descent toward the goal of healing, reconciliation, and eliminating racism as we seek to dismantle white privilege.

- Grants can be a one-time amount or can be given in payments over a set amount of time depending on the needs of your ministry's initiative. Grant cycles will be determined on a case-by-case basis.
- Grants can be used to support Cooperative Congregations or Churches coming together for a coordinated effort.

If chosen as a grant recipient, your ministry can expect to:

- Be excited! Dream! Be asked about your spiritual discernment for this request.
- Receive a liaison from Salem Presbytery's Church Growth and Transformation committee (CGAT) for support; Identify one liaison from your ministry to work directly and be the main contact for CGA.
- Welcome and expect regular check-ins from your CGAT liaison.
- Share updates with CGAT quarterly throughout the determined grant cycle.

Coalition for Alternatives to the Death Penalty we are focused on adding North Carolina to the list of states who no longer allow this arbitrary and retributive practice. - Cash Bail Reform is a part of our criminal justice system coming under the microscope for its unfair application. It is also a misunderstood piece of the justice system, making it harder to reform. The Council has assembled a team of representatives from several of our member denominations to help educate all of us about Cash Bail Reform and advocate for better practices. - Confederate Monument Removal. Related to the above, but with its own emphasis, the Council has joined the work of the N.C. Commission on Racial and Ethnic Disparities in Criminal Justice in their effort to move confederate monuments from courthouse lawns. - Eco-Justice Connection (EJC). This multi-faith program area focuses on environmental and climate justice, with an emphasis on "advocating with compassion." A keystone initiative of EJC is NC Interfaith Power & Light. EJC's program mission is to educate, inspire, and mobilize people of faith and conscience to act on climate change as a moral imperative. - Partners in Health and Wholeness (PHW) provides tools to help faith communities form healthy habits by supporting congregation-based health ministries with resources and mini-grants. - The Opioid Crisis educates faith leaders about compassionate responses to these growing health concerns and opportunities to reduce the associated stigmas. Faith Journey Richard Collier

For the first 34 years of my life, I was a Christian. The next 38 years have seen me as a Presbyterian. To God Be the Glory!

I was born to Christian parents who attended First Christian Church (Disciples of Christ) in Beckley, WV. We were always involved in everything going on at the church. Some of my earliest memories are of church. Church in the 50s was the center of life in the south and this was certainly the case for FCC Beckley... we were on Court House Square and across the street from the Greyhound Bus Station. Our Sunday morning worship service was attended by about 250 congregants and Sunday School before worship saw up to 500 attendees! My father helped teach the very large Men's Class, taught bible in the Chapel and served as an Elder, and Mom was very involved with the Friendship SS Class and a Ladies Circle group.

Nearly every year the church had a week of services, revival services as such. Often there would be a special guest speaker and the one I remember best was a gentleman who delivered the message while his wife crafted a beautiful painting. I seem to remember that at the end of the message, the painting would be tied to the topic and someone in the congregation would take the painting home. It was during one of these services that I came forward as an almost 10-year-old and made my confession of faith and was baptized on May 7, 1961 by Dr. A. H. Wilson. It was about that same time that I was part of Madeline Vaughan's Sunday School Class and she was truly a wonderful influence on my life. I can still remember her portrayal using a felt board of Joseph being thrown into that pit with his multicolored coat. Wonderful memories.

I was always very involved in the youth programs at FCC... Chi Rho for Junior High and CYF (Christian Youth Fellowship) for Senior High. We had programs every Sunday evening and Summer Camps each year... I never missed – these were the highlights of my summer. One summer, because of a sizable donation to the church, a large group of youth and advisors traveled to London, Paris, Brussels, and Amsterdam. To put it all in perspective and within a time frame, when I was in CYF, we had a "liturgical dance group" made up of the 15 or 20 youth group members who performed at the various churches in our district. The movements interpreted recorded versions of "The Lord's Prayer" and "I'd Like to Teach the World to Sing" (from the Coke commercial).

Following High School, I attended college at West Virginia Institute of Technology in Montgomery WV, a little over an hour's drive from home. Although I was in the WVIT Golden Bear Marching Band, I never spent a weekend at college... always coming home for the weekend, attending church and singing in the Chancel Choir. After college graduation in 1974, with a degree in Mechanical Engineering, I was married and we settled down in Beckley. After a couple of years, our Church Choir Director moved on and I was asked by the church to assume that role. I did so and continued to do so until we left WV for NC in 1985.

Also following college graduation and marriage, my wife and I spent time sponsoring youth group and teaching the young adult Sunday School Class, the Disciples Class. I was also a Church Deacon, then Elder, served on the church General Board, and also was a representative to the Regional Board (our

then Elder, served on the church General Board, and also was a representative to the Regional Board (our Presbytery). We never thought we would leave Beckley, but the Lord closed and opened doors to make our way to North Wilkesboro NC in 1985. After searching for a church home (there were no Disciple of Christ churches in our county), we felt comfortable in North Wilkesboro Presbyterian Church, so, along with our two young sons, two and six, we joined with this congregation. We immediately became very involved, and I was elected an Elder and Clerk of Session several times, serving on an early Long Range Planning Committee, singing in the Choir, teaching the young adult Barksdale SS Class for nearly 35 years (most of it without an assistant), leading several church committees, chairing a Pastor Nominating Committee and a DCE Search Committee, and attending Presbytery and a Synod meeting as NWPC and Salem Presbytery representatives. All of this was while also having two sons very involved in youth groups, Massanetta and Montreat planning groups and leadership.

About 8 years ago, I felt a calling to consider becoming a Lay Minister. I had two strong mentors in Gordon Finley and Sid Crunk who had gone through the Salem Presbytery program and served at Glendale Springs Presbyterian Church. I was discouraged at that time as Salem Presbytery no longer had their program and I was told there was no need at that time. About three and a half years ago, our minister and an elder attended a Presbytery Meeting where the need was once again stated and they came back to North Wilkesboro and told me I should consider the program again. The mention of it quickened my spirit once again and I learned of the Christian Leadership (CRE) program in the Presbytery of Western NC... I soon enrolled and went through their two-year program. I followed that with an internship at NWPC, completing it last May. I am now finalizing the steps necessary to allow me to serve as Pulpit Supply in other churches and, if the Lord leads me there, to consider Lay Ministry in a congregation.

Statement of Faith Richard Collier

I believe in God, the Father Almighty, creator of all things that were created. I believe fully that God is Omnipotent, all powerful; Omnipresent, all present; Omniscient, all knowing; and Omni temporal, apart from time constraints. Only God's Grace, extended to humanity through the suffering, death, resurrection and ascension of God's Son, Jesus Christ can sustain and ultimately save us!

I believe in Jesus Christ, the only Son of God, and that He was born of the Virgin Mary through the Holy Spirit, lived a perfect life and then suffered under Pontius Pilot, who had Him crucified on a cruel cross. Jesus' presence physically in our world and His resurrection enable our hope of dwelling in Heaven with God for all eternity. Jesus was fully human and fully God. Jesus fulfilled the Old Testament scriptures but was not recognized by the Jewish community as their Messiah, or Anointed One, because while He preached Love, they were looking for a Military Messiah to restore them to the place of dominance they had experienced under Jesus' ancestor, King David. Jesus' teachings and miracles taught and showed us that we should live and treat others with love. He was betrayed by His disciple Judas, was stricken and afflicted under His Roman captors, and then hung on a cross where He suffered, bled and died, not for anything He had done, but as the sacrifice and substitution for human sin, our rejection of God. Jesus rose on the third day, defeating Satan's most powerful weapon, death, and then walked again among His Disciples and followers for 40 days, giving them final instruction and insight into Himself and His Father. He then ascended into Heaven where He is seated on the right hand of the Father Almighty, where He makes intersession for the Saints. The Word tells us that He will come again to judge the living and the dead.

I believe in the Holy Spirit, the third person of the holy Trinity. Fifty days after Jesus' Resurrection, on Pentecost, the Holy Spirit descended upon the Disciples and Believers in Jesus. This same Holy Spirit dwells in the hearts of all believers today, guiding us and showing us what the Father's Will is for us... showing us right from wrong, if we but listen. The Holy Spirit guides us in our understanding of scripture when we pray for His inspiration and wisdom, to understand that these are the Words of our Creator speaking to us. Jesus taught His Disciples that He needed to ascend to Heaven so that the Holy Spirit might transcend upon them and empower them.

I believe in the Trinity. In the beginning when God was creating all things, Jesus Christ and the Holy Spirit were with Him, as His Word tells us. These three distinct individuals make up what we refer to as the Trinity. **God** sent His **Son** that the world thru Him might be saved from their rejection of God, and the **Holy Spirit** could act within believers' lives.

I believe in the Church of which Jesus is the Head. Through Jesus' death, burial, resurrection and ascension, the Church was founded when the Holy Spirit came down on the believers gathered on Pentecost. The universal Church is not just a particular body or denomination of believers, but is made up of all believers and the saints who have gone on before us. The local church is where Christians learn and share their Love and work in Jesus' name to help all the people in our world.

I believe in the Holy Scriptures, Old and New Testaments. I believe it is the infallible and inspired Word of God provided by the Holy Spirit to the various authors from Genesis through Revelation for study and proclamation by all believers. As someone has said, I believe everything in the Bible is true and most of it actually happened (as written).

I believe in Holy Communion and Baptism as the only sacraments established by our Lord, Jesus Christ. The Sacraments were created as outward symbols of the grace given to us by our Lord. Holy Communion enables us to remember the death and resurrection of Jesus, using the Words spoken to His Disciples at the meal as they shared the bread before His betrayal, death and Resurrection... Do this in Remembrance of Me. And when sharing the cup Christ stated a new covenant in His blood, which was poured out for His Disciples, and us. Baptism reminds us of the Lords' Baptism done by John the Baptist in the Jordan River, when Jesus' Father in Heaven spoke His approval of what Jesus was beginning with His Ministry here on earth. When believers are baptized, we enter into His Baptism as a sign of our confession of Faith in Him, and the Church agrees to participate in the spiritual nourishing of the one baptized.

Faith Journey John ("Jack") Donovan

My <u>spiritual</u> journey started with joy in a faithful, loving and beloved family and neighbors. Thereafter, it continued with obedience to catechism faith, then with wayward searching, then meditative discernment, then contemplative prayer, then loving God and caring for neighbor and self as Jesus showed.

My <u>faith</u> journey started with a deep sense of peace and belonging, due to the caring and kind goodness of my parents, their siblings' families, and our neighbors. In them I trusted life. A marker of this was my third Christmas Eve evening: my parents and I were sitting in front of our Christmas manger scene, my baby brother asleep in his crib, and the baby Jesus in his crèche surrounded by representatives of the Creator and all creation– and I somehow knew that was us.

As a young Roman Catholic I was expected by my family and our church to absorb Christian doctrine as authorized in the Church catechism. Every Friday night we ate fish per the Vatican. Every Saturday I memorized doctrine for the next morning's Sunday School class with the nuns. One Saturday per month I strove to examine life to see if I had anything to confess. My ardor was gentled by my extended family, which did not hold with the extremes of Church authority – for example, on birth control, consigning unbaptized babies to Limbo, or emphasizing a fiery hell over a caring, forgiving God.

My last summer in college was spent with a few classmates building adobe houses for impoverished indigenous families in Mexico City's barrios. Such work is Christ's way, said the organizing priests. Each of us lived nights and weekends with extremely wealthy families, arranged by the priests. Spending time with them, then with the barrio families, and often with the suffering images of Christ in the Mexican cathedrals gradually brought epiphanies. All was not right or well – not even in the Church - yet.

After college, I was a Peace Corps teacher in Micronesia, a USAID refugee worker in Vietnam, and a Community Action Agency worker in Boston's struggling neighborhoods. Over this time I began to discover there was a great deal about life and the human spirit that I needed, and wanted, to learn.

I tried many denominations over time, but could not find one for my needs – one that seemed to have a path with God amongst God's people and God's creation. Finally, I settled on a Unitarian church that let me explore my questions widely. Judaism taught me covenant and community. Buddhism taught me awareness, reflection, and intention. Hinduism taught me the presence and beauty of God. Systems analysis taught me interconnectedness and complexity. Neuroscience taught me discernment and resilience. Psychology taught me life's developmental nature. Fiction-writing taught me narrative. Marriage to a Presbyterian (USA) minister and parenting our children taught me that all the above is found in the being and life and parables of Jesus. And so I follow him as best I can, for my salvation and the world's.

To pass that on is why I have had joy in serving Presbyterian congregations and believe that such a vocation points to the glory of God.

Statement of Faith John ("Jack") Donovan

I believe in God as source of grace and truth and as creator of heaven and earth, I believe it is this God whom Jesus called our Father and whose world, when sought in accord with the way of Christ, ends all anxiety and provides all that our bodies need and all that our souls hope for. I believe it is God who by grace gives us life and restores us when we are weakened by uncovenantal waywardness in ourselves and our world.

I believe in Christ Jesus, fully God, fully human - one with God and one with us. I believe it is Christ who shows us God's truth and way and life, which continually re-open and restore the world with the power of grace. I believe Christ calls us into relationship with himself and therein with God. I believe our developmental needs, materialistic values, and difficulties in life cause us to lose touch with God's grace and truth and to lose track of God's gracious way by which are blessed our souls and our world. I believe Christ calls us - by his being, words, and deeds - to understand and do God's will by loving and caring for God and one another with our whole heart, soul, mind and strength, as God has always loved us.

I believe the way of God's grace and truth is revealed by Jesus in the gospels and that this revelation provides sufficient instruction in faith and spirit for us to continually return to God and care for all. I believe Jesus' revelation is anticipated and supported throughout the scriptures from Genesis on.

I believe in God the Holy Spirit as bringer and renewer of life. I believe that the Spirit proceeds through the eons and generations from the beginning, bearing into our souls the grace by which we are created and grow and by which we come to seek and experience God. I believe the Spirit provides us with the strength of heart, mind, soul, and body to live, to heal, to find God in Christ and cosmos, and to be in communion with Christ in God's world.

I believe the Church is a community for all humankind in all its diversity. I believe the Church is the body of Christ – that is, his instrument of witness to spread his ways of grace for healing souls and glorifying God. Older Adult ministry was Vicki's passion but it came with lots of pastoral care and the loss of dear friends.

In Holy Week of 2003, Vicki came down with pneumonia. She was never able to regain her full strength and left Calabash burnt out from trying to still do it all. This experience is one of the reasons she works on the COM Taskforce for Care, which she hopes will be a catalyst for better care for pastors who are burnt out.

Her ministry in Salem Presbytery has been limited due to health issues but she has served on COM, mentored several CREs, and has been active as a supply preacher.

The Rev. John C. Elam Retirement

"...the law of the Spirit of life has set you free in Christ Jesus from the law of sin and death. For God has done what the law, weakened by the flesh, could not do." (Romans 8:2 ESV)

Though John Elam did intentional and fruitful ministry throughout his career as an attorney, as a lawyer he is better placed than most to understand the limits of what laws can do to aid and bring justice for human beings, and so for the last third of his career, he has focused on the ministry of the Spirit and the Word of God through Jesus Christ.

As he transitioned to pastoral ministry from decades of service as a founding partner in a law firm, John wrote, "Somewhere, there is a Presbyterian church that is yearning to learn God's Word; one that... claims the power and life-giving authority that flows from the Biblical and doctrinal foundations of our faith... [Such a] church will find, in the heart of this man, a hunger and a drive to proclaim authentically the gospel; hunger born through years of advocacy before judges and juries. John's desire has been to "demonstrate, in word and deed, a humility that makes Christ's claim on my life evident to all." John, you have done this well. You have humbly and faithfully served your Lord at Franklin, Salem Presbytery, the communities of central North Carolina, and your marriage with Eve.

- Approved that the following Ruling Elders be granted permission to celebrate the Sacrament of the Lord's Supper at Grace PC, having completed training with the Rev. Jud Milam: Reginald McNeill, Sandra Thomas, and Carol Wilson.

Business of the Executive Council:

- Approved the docket for the September 2023 meeting of Presbytery;
- Received regular, detailed financial reports from the Budget and Finance Committee;
- Approved the MIF for the General Presbyter and authorized it to be placed in the Church Leadership Connection;
- Heard a presentation by the leadership at Massanetta Springs;
- Approved the proposal from Budget/Finance Committee to name the Stated Clerk and the Budget/Finance Moderator as signators on the Merrill Lynch investment account;
- Received a report on the work of the Black Caucus;
- Received a report from the Campus Ministry Task Force, and learned that the Task Force
 is restructuring the way that Salem funds its campus ministries, with new emphasis on
 developing accountability for the funds that are deployed;

COMMUNICATION OF MATERIAL WEAKNESSES AND OTHER MATTERS

To the Management and the Executive Council of Salem Presbytery Clemmons, North Carolina

In planning and performing our audit of the financial statements of Salem Presbytery's as of and for the year ended December 31, 2022, in accordance with auditing standards generally accepted in the United States of America, we considered Salem Presbytery's internal control over financial reporting (internal control) as a basis for designing our auditing procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Salem Presbytery's internal control. Accordingly, we do not express an opinion on the effectiveness of the Salem Presbytery's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and therefore material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be material weaknesses and other deficiencies that we consider to be significant deficiencies.

MATERIAL DEFICIENCIES

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency or combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Organization's financial statements will not be prevented, or detected and corrected on a timely basis. We consider the following deficiencies in Salem Presbytery's internal control to be material weaknesses:

Separation of Duties:

a. Finance Committee/Treasurer Oversight Responsibilities

Salem Presbytery's Finance Committee is responsible for the treasury and accounting functions of the Organization. We recommend management consider having the following procedures performed by a Finance Committee designate (e.g. General Presbyter, Office Manager, etc.).

- Review and formally approve monthly bank and investment statement reconciliations prepared by the Financial Secretary. Consider having bank and investment statements sent directly to the designate for review prior to forwarding to the Financial Secretary.
- 2. Review and formally approve all journal entries recorded on the Organization's general ledger.
- 3. Review and formally approve monthly detail posting journal (or monthly detail general ledger) and cross reference ending account balances to amounts reflected on the Organization's operating statements.

- 4. Review and formally approve overall reconciliation of contribution records subsidiary total to totals posted to the Organization's general ledger.
- 5. Oversee the periodic distribution/mailing of contribution statements to Contributors.

Response:

Due to limited staff and other circumstances, Salem Presbytery continues to address this finding.

OTHER MATTERS

Accounting Policies and Procedures Manual

We recommend a formal policies and procedures manual be developed. In developing such a manual, consideration should be given to including job descriptions; procedures for initiating, handling and recording receipt and disbursement activity; daily, weekly, monthly and annual work/closing punch lists; source document examples, and examples of operating statements, ledgers and journals, including chart of accounts.

Response:

Due to limited staff and other circumstances, Salem Presbytery continues to address this matter.

INDEPENDENT AUDITORS' REPORT

To the Members of the Executive Council Salem Presbytery Clemmons, North Carolina

Opinion

We have audited the accompanying financial statements of Salem Presbytery (a nonprofit organization), which comprise the statement of financial position as of December 31, 2022, and the related statements of activities and changes in net assets, functional expenses, and cash flows for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of Salem Presbytery as of December 31, 2022, and the changes in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America.

NOTE A: NATURE OFACTIVITIES

Salem Presbytery (the "Presbytery") is a not-for-profit organization established under the laws of the State of North Carolina and operates as a religious organization. Salem Presbytery is called to fulfill the mission and governing responsibilities given by Christ, as interpreted by the Constitution of the Presbyterian Church (U.S.A.). The Presbytery is a non-profit corporation consisting of Presbyterian churches and ministers in northwestern North Carolina.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The Presbytery's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Support and revenue is recorded in the period earned and expenses are recorded in the period incurred.

Financial statement presentation

The accompanying financial statements are intended to present only financial position and activities for Salem Presbytery.

The Presbytery has adopted certain elements of FASB ASC 958 "Not-for-Profit Entities". In August 2016, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) No. 2016-14, Presentation of Financial Statements of Not-for-Profit Entities. ASU 2016-14 requires significant changes to the financial reporting model of organizations who follow the not-for-profit repotling model. The changes include reducing the classes of net assets from three classes to two - net assets with donor restrictions and net assets without donor restrictions. The ASU also requires changes in the way certain information is aggregated and reported by the Presbytery, including required disclosures about liquidity and availability of resources and increased disclosures of functional expenses. The Presbytery adopted the ASU effective January 1, 2018.

Net assets of the Presbytery consist of the following:

Without Donor Restrictions:

Budget Fund - These net assets are unrestricted and available for general budget activities of the Presbytery.

Board Designated - these net assets are to be used for specific purposes as determined by the Council of the Presbytery. These also include Council designated, quasi-endowment type funds where the Council designated resources are available for any uses the Council deems appropriate, along with any related income derived from the investment of such funds.

With Donor Restrictions:

These net assets are restricted by donors to be used for some specified purpose. These also include donor mandated, quasi-endowment type funds where donor-restricted resources are available for use for specified purposes, along with any related income derived from the investment of these net resource assets, donor-restricted resources to be held by the Presbytery in perpetuity (as endowment funds) with any related income derived from these net assets being available without donor restrictions for donor-specific purposes.

Cash and cash equivalents

The Presbytery considers all cash accounts and all highly liquid investments with a maturity of three months or less to be cash and cash equivalents.

Contributions and contributions receivable

Contributions, unconditional promise to give, gifts, and grants collected are recorded as either without donor restrictions or with donor restrictions depending on the existence or nature of any donor restrictions.

Contributions and unconditional promises to give are recorded as contributions receivable and support when made or the promise is conveyed, whichever is earlier. Contributions of assets other than cash are recorded at estimated fair value on the donation date. Support that is restricted by the donor is reported as increases in either net assets with temporary restrictions or net assets with perpetual restrictions depending on the nature of the restrictions. When a donor restriction is met, donor restricted net assets are reclassified to net assets without donor restrictions.

Endowment contributions are maintained in perpetuity by the Presbytery. Income earned on these contributions is used by the Presbytery based on the donor-imposed stipulations and/or may be used for unrestricted purposes absent donor-imposed stipulations.

Investments

Investments consist primarily of assets invested in marketable equity and fixed income securities, and certificate of deposit accounts. Investments in marketable equity securities with readily determinable fair values and all investments in debt securities are measured at fair value in the statements of financial position. Fair value of marketable equity and debt securities is based on quoted market prices. Investment income or loss, including realized or unrealized gains and losses on investments and interest and dividends, is included in the change in unrestricted net assets unless the donor restricts the income or loss.

Investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the fair value of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment policy

Given the Presbytery's fiduciary responsibility for the funds entrusted to it by the member churches and other sources, the primary investment objective of the Presbytery is and will be the preservation of principal. At least 70% of investment portfolio should at all times be based on conservative risk tolerance and emphasize principal preservation over return on investment. However, the investment advisor should include interest rate risk as a criterion in making investment decisions to address market sensitivity. Up to 30 % of the total portfolio may at any given time be invested in moderate risk instruments in order to generate a greater rate of return. Of this 30%, nothing shall be invested in anything lower than BBB-grade instruments, with no more than 10% of the total portfolio in real estate-backed securities at any given time.

Fair value measurements

Cash and cash equivalents, receivables, accounts payable and accrued expenses, and capital lease obligations are financial instruments with carrying amounts that approximate fair value because of the short maturity of those instruments.

Property and equipment, net

Property and equipment are carried at cost. Donated property and equipment items are recorded at fair market value on the date received. Depreciation is provided over the estimated useful lives of the respective assets on a straight-line basis.

Income taxes

The Presbytery is exempt from income taxes under Section 50l(c)(3) of the Internal revenue Code (the "Code"). Accordingly, no provision for income taxes is reflected in the accompanying financial statements. Qualifying contributions to the Presbytery are tax deductible.

The Presbytery evaluates all tax positions to identify any that may be considered uncertain. All identified material tax positions are assessed and measured by a "more-likely-than-not" threshold to determine if the tax position is uncertain and what, if any, the effect of the uncertain tax position may have on the financial statements. No material uncertain tax positions were identified during 2022.

Agency transactions

The Presbytery acts as an agent or intermediary between churches within its jurisdiction and the Synod of the Mid-Atlantic and General Assembly. Agency transactions receipted and disbursed during the current period have been netted for financial statement presentation purposes.

Estimates and assumptions

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

NOTE C: CASH AND CASH EQUIVALENTS

The Presbytery maintains its cash in financial institutions insured by the National Credit Union Administration (the "NCUA") and the Federal Deposit Insurance Corporation (the "FDIC"), as applicable. At various times, cash and cash equivalents on deposit in certain financial institutions may exceed the NCUA and FDIC limits. The Presbytery does not believe it is exposed to any significant risk.

NOTE E: FAIR VALUE MEASUREMENTS

The Presbytery has adopted the provisions of FASB ASC 820 "Fair Value Measurements". Under ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Financial Accounting Standards Board issued ASC 820, Fair Value Measurements. FASB ASC 820 defines fair value, establishes a framework for measuring fair value, and expands disclosure about fair value. This statement does not require any new fair value measurements; rather it applies under other accounting pronouncements that require or permit fair value measurements. Assets recorded at fair value are categorized upon the level of judgment associated with the inputs used to measure their fair value. Level inputs, as defined by FASB ASC 820, are as follows:

Level Input:	Input Definition:
Level I	Inputs are unadjusted, quoted prices for identical assets or liabilities in active markets at the measurement date.
Level II	Inputs, other than quoted prices included in Level I, that are observable for the asset or liability through corroboration with market data at the measurement date.
Level III	Unobservable inputs that reflect management's best estimate of what market participants would use in pricing the asset or liability at the measurement date.

NOTE E: FAIR VALUE MEASUREMENTS (Continue)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a brief description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

Interest in registered investment companies (mutual funds): Value at the net asset value of shares held by Salem Presbytery at year end.

Corporate debt securities: Certain debt securities are valued at the closing price reported in the active market in which the bond is traded.

Other investments: Valued based on Market Approach including dealer quotes, trade data, two-sided markets institutional bids, comparable trades and other news media.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Salem Presbytery believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE I: ENDOWMENT FUNDS

Salem Presbytery maintains several donor-mandated and Council designated endowment funds. Salem Presbytery has, to the extent practical, segregated the cash and investments supporting the underlying principal (or corpus) and related unexpended income of these funds from other assets and classified and reported them based on the existence or absence of donor-imposed restrictions.

Salem Presbytery has interpreted the Uniform Prudent Management of Institutional Funds Act (UPMIFA) as requiting the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds absent explicit donor stipulations to the contrary. As a result of this interpretation, Salem Presbytery classifies as perpetual restricted net assets (1) the original value of gifts donated to the permanent endowment, (2) the original value of subsequent gifts to the perpetual endowment, and (3) accumulations to the perpetual endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund. All other endowment investment returns, typically dividends and interest income, are available for appropriation and, therefore, are classified as net assets without donor restrictions of net assets with donor restrictions that are temporarily restricted, as applicable, until appropriated for expenditure. In accordance with the Act, Salem Presbytery considers the following factors in making a final detem1ination to appropriate or accumulate donor- restricted endowment funds:

- 1. The duration and preservation of the fund
- 2. The purposes of Salem Presbytery and the donor-restricted endowment fund
- 3. General economic conditions
- 4. The possible effect of inflation and deflation
- 5. The expected total return from income and the appreciation of investments
- 6. Other resources of Salem Presbytery
- 7. The investment policies of Salem Presbytery

The Salem Presbytery has adopted investment and spending policies for endowment assets that attempt to provide a predictable stream of funding to programs supported by its endowment funds while seeking to maintain the fair value of the endowment assets. Endowment assets include those assets of donor-restricted funds that Salem Presbytery must hold in perpetuity or for a donor-specified period as well as Council-designated funds. The policies provide Salem Presbytery a framework for governing its investment practices in manner that maximizes investment returns while also preserving and protecting its invested assets. For those funds of a long-term nature, the Salem Presbytery policies allow for a growth and income strategy in which investment returns are achieved through both capital appreciation (realized and unrealized) and current yield (dividends and interest), and allow for investment in equity and fixed income securities. For funds with a short-term horizon (less than five years), capital preservation is important, and investment in money market funds, CDs, mutual funds and short-term government securities is allowed.

The Presbytery has a policy governing the appropriation and expenditure of its endowment funds. Generally, for substantially all permanently restricted funds, annual appropriations are limited to the current yield of these funds. For all other funds (unrestricted and temporarily restricted), appropriations are either limited to the current yield of the fund or that amount deemed appropriate by Salem Presbytery management.

A donor-restricted endowment fund is considered to be underwater if the fair value of the fund is less than either the original gift amount or the amount required to be maintained by the donor or by law. Presbytery management is not aware that any of its perpetual endowment funds are underwater. Presbytery policies do not permit spending of the perpetual endowment fund corpus, unless specifically allowed by the donor or relevant laws and regulations.

NOTE J: LIQUIDITY AND AVAILABILITY OF RESOURCES

The Presbytery regularly monitors the availability of resources required to meet its operating needs and other contractual commitments, while also striving to maximize the investment of its available funds. For purposes of analyzing resources available to meet general expenditures over a 12-month period, the Presbytery considers all expenditures related to its ongoing mission-related activities as well as the conduct of services undertaken to support those activities to be general expenditures.

In addition to financial assets available to meet general expenditures over the next 12 months, the Presbytery operates with a balanced budget and anticipates collecting sufficient support and revenue to cover general expenditures not covered by donor-restricted resources.

The Presbytery's governing council has designated a portion of its unrestricted resources for endowment and other purposes. Those amounts are identified as board-designated in the table above. These funds are invested for long-term appreciation and current income but remain available and may be spent at the discretion of the Council.

NOTE K: FUNCTIONAL EXPENSES

The financial statements report certain categories of expenses that are attributable to more than one program or supporting function. Therefore, these expenses have been allocated on a reasonable basis that is consistently applied. Direct expenses are recorded by category, by function determined to be benefited. Indirect costs, including certain capital outlays, are allocated to the function estimated to be benefited, principally based on direct costs incurred.

NOTE L: LOAN GUARANTEES

As of December 31, 2022, The Presbytery has guaranteed a Presbyterian Church Investment and Loan Program, Inc. ("PCILP") loan with principal balances that totaled approximately \$511,000 at December 31, 2022. The Presbytery could potentially become liable for the unpaid principal balance, accrued interest, and costs, if any, for each instance in which a Presbyterian church defaults on its loan obligation.

As of December 31, 2022, the Presbytery has guaranteed eight Presbyterian Church Investment and Loan Program, Inc. ("PCILP") church mortgage grants, with grant amounts totaling approximately \$47,000 as of December 31, 2022. The Presbytery could potentially become liable for paying back the grants, if any, in each instance where a member church does not repay the grant in the events of closing the church or leaving the denomination of the Presbytery.

NOTE M: RETIREMENT PLAN

The employees of the Presbytery participate in a defined contribution retirement plan administered by the Board of Pensions of the Presbyterian Church (U.S.A.). The Presbytery's contributions are equal to 8.5% of the annual salary of participating employees. During the year ended December 31, 2022, Salem Presbytery's contributions to the plan totaled \$26,306.

NOTE N: CONTINGENT LIABILITIES – LAWSUIT

The Presbytery has been named in a few lawsuits related to Boy Scouts of America. Currently, all lawsuits are stayed due to the Chapter 11 bankruptcy action of the Boy Scouts of America Inc. As of July 17, 2023, there has been no further action related to the lawsuit.

NOTE O: SUBSEQUENT EVENT

The Presbytery evaluated the effects subsequent events would have on the financial statements through July 17, 2023, which is the date the financial statements were available for issuance.

In April and June of 2023, the Presbytery sold two buildings that were previously used by a church and a homeless ministry. According to the reversion clause, the Presbytery regained ownership of these buildings after the closure of the church and the homeless ministry. The buildings were sold for \$425,000 in April and \$242,000 in June.

We have audited the financial statements of Salem Presbytery for the year ended December 31, 2022, and have issued our report thereon dated July 17, 2023. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. Accordingly, we are providing you with the following infom1ation related to our audit.

Our Responsibility under U.S. Generally Accepted Auditing Standards

As stated in our engagement letter dated February 23, 2023, our responsibility, as described by professional standards, is to express an opinion about whether the financial statements prepared by management with your oversight are fairly presented. in all material respects, in conformity with U.S. generally accepted accounting principles. Our audit of the financial statements does not relieve you or management of your responsibilities.

Our responsibility for the supplementary information accompanying the financial statements, as described by professional standards, is to evaluate the presentation of the supplementary information in relation to the financial statements as a whole and to report on whether the supplementary information is fairly stated, in all material respects, in relation to the financial statements as a whole.

Planned Scope and Timing of the Audit

We performed the audit according to the planned scope and timing previously communicated to you in our engagement letter to you dated February 23, 2023.

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Salem Presbytery are described in Note B to the financial statements. As described in Note B, the Church changed accounting policies related to the classes of net assets from three classes to two - net assets with donor restrictions and net assets without donor restrictions, changes in the way certain information is aggregated and reported by the Church, including required disclosures about liquidity and availability of resources and increased disclosures on functional expenses by adopting FASB Accounting Standards Update (ASU) No. 2016-14. Presentation of Financial Statements of Not-for-Profit Entities, in 2020. We noted no transactions entered into by the Church during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the functional allocation of expenses is based on actual and allocated percentages of historical expenditure trends. We evaluated the key factors and assumptions used to develop the functional allocation of expenses in determining that it is reasonable in relation to the financial statements taken as a whole.

Management's estimate of depreciation on its property and equipment at rates judged to approximate the benefit provided by these assets over their estimated useful lives. We evaluated the key factors and assumptions used to develop the depreciation estimate in determining that they are reasonable in relation to the financial statements taken as a whole.

Management's estimate of the allowance for doubtful accounts based on a detail review of slow-paying and past due accounts. We evaluated the key factors and assumptions used to develop the allowance in determining that it is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements was:

The disclosure of fair value measurements in the notes to the financial statements -- the fair values are based upon quoted market prices confirmed with a third party broker and correspondence with other third parties. We evaluated the key factors and assumptions used to develop the fair value measurements in determining that it is reasonable in relation to the financial statements as a whole.

The financial statement disclosures are neutral, consistent and clear.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. The attached schedule summarizes uncorrected misstatements of the financial statements. Management has determined that their effects are immaterial, both individually or in the aggregate to the financial statements taken as a whole.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated July 17, 2023.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Church's financial statements or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Church's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

With respect to the supplementary information accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with U.S. generally accepted accounting principles, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the supplementary information to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

This information is intended solely for the Church Council and management of Salem Presbytery and is not intended to be and should not be used by anyone other than these specified parties.



Since 1999, Comfort Zone has helped 21,000+ children.

THE NEED

An estimated I out of 14 children in the U.S. will experience the death of a parent or sibling before they reach the age of 18. Over 5.2 million youth are bereaved, and the number more than doubles by age 25, to 13.2 million. Childhood bereavement is a prevalent and critical public health issue that can have a profound impact on future well-being.


