When our daughter was young, as she would leave for school in the morning, one of the last things we would say to her was "Make good choices!" This is also a simplified explanation for what your Designated Presbyter for Transformational Ministry is responsible: empowering uninstalled churches to make good choices. I spend, however, a fair amount of time explaining that I am not visiting your church because Presbytery wants to close it. I am visiting your church because Salem Presbytery is looking to empower it (from my mouth to God's ear).





Sometimes the painful Session decision to dissolve a church is an incredibly faithful choice. Sometimes I can make a guess at how long a church will survive. I certainly don't know exactly when a church might dissolve, but I do know that **certain congregational** and Session decisions can expedite the journey.

Here are some of **conversations** of which I have been a part over the last twenty months serving with our uninstalled churches, which may put them on the path to closure:



- We only want a pastor where we don't have to pay benefits
- This is *our* property, *our* church, *our* pastor
- I can't remember the last time we did an audit
- I (we) don't attend Presbytery meetings because... they are too far away, we don't 'do' technology (ZOOM), why should I (because you promised: BOO W-4.0404)
- We cut the benevolence (mission) budget line to pay for heating oil
- Without children and young families, we will never be a church (again)
- We don't care what the (Presbytery) policies are...we'll pay what we can pay until we can't and our pastor is fine with that
- We don't need officer training it's the same people again because no one else will do it
- We can't hire a pastor because our building needs too much work
- We don't want to drive 5 minutes to worship with [the neighboring PCUSA church] on 5th Sundays
- All we need Presbytery to do is get us a pastor
- We can (will) not change our worship time

I share these because some of these decisions and beliefs place churches on a path where recovery may not be an option. Lack of funds or people may preclude a church from doing what they would like to do, however, **those realities do not preclude God's people from considering what it means to be the Church in ways that are not property or pastor dependent.** Our PCUSA beliefs and polity provide the framework to recognize that we are a people living out our faith through **relationships and connection, that we are all to participate** in these challenging conversations to prayerfully discern solutions **together**.

As we stand on the precipice of a new chapter in this Presbytery, may we make good choices to be the Church in the image of Jesus Christ!

FOR ACTION:

Modification to Dismissal Policy

One simple element in the Dismissal Policy, adopted by Salem Presbytery in April 2016, has been found to be in violation of a provision in the Book of Order - and I will be moving new language in this one section. (See the proposal in today's packet.)

Section 4, item D: In the current policy, the vote of the congregation for dismissal appears to be binding upon the Session. The request for dismissal of the congregation to another Reformed body is not among those items that are under the purview of the congregation. (G-1.0504).

Ref: The Impact and Speed of Time – It's Been a Good Year

Date: December 19, 2023

Where has the time gone? Our getting older makes time so much more precious and now we are 12 days away from 2024. Hopefully, the time we spend engaged in ministry and service to Christ Jesus through the synod of the Presbyterian Church USA., has been productive as you reflect upon the year.

The Synod Moderator David Cho and the Executive Committee express thanks to the Presbytery of Salem for being such a meaningful partner in mission and ministry in 2023. Our presbyteries are continuing to recover from COVID and we are delighted that you are rebounding also. We are pleased that nine of the 14 presbyteries have become Matthew 25 Councils, and others are closing in. Nearly four years ago, synod set aside \$6,965 to stimulate and encourage movement deeper into or towards Matthew 25. Most presbyteries have requested these funds to assist with presbytery representatives to attend the Matthew 25 Summit in January. Keep in prayer AKAP! Consider sending a financial gift to AKAP as the presbytery appeals a civil court property decision. The synod at this point has donated \$20,000.

Leaders across and beyond the region continue to reflect positively on the impact that 252nd Synod Assembly had upon the more than 114 Commissioners, COM/CPM, Black Church Leaders, and Presbytery Leaders. The launching of the Next Generation Initiative will allow our synod to be known as "That Synod that creates a culture and strategy to identify, nurture, and coach the Next Generation of African American Leaders for the PCUSA and beyond." We also said farewell to Interim EP Vanessa Hawkins and welcomed EP Bruce Grady to NHO; farewell to TGP Barbara Smith and welcome GP Tony De La Rosa to SAL; and we said farewell to GP Liza Hendericks and said hello to Interim Parttime GP Jeff Bell to EVA.

As we Praise God for an Amazing Year in Advance, can the synod anticipate your support in 2024? Thanks for providing leadership to serve on synod's committees and commissions.

Salem Presbytery Guidelines for Congregations Considering a Request to Presbytery to be Dismissed (Approved by Presbytery, 4/30/2016)

- IV. D. After the legal agreement has been approved by the Congregation, the Session may no sooner than three months and not later than six months after the first hearing described above (Presbytery having the right to modify these time limits for good reason in the light of negotiations for the legal agreement in IV.C.3) request the Presbytery to call a second hearing of the Congregation, and to establish the rules for that hearing.
 - * Due notice shall be mailed to all members of the Congregation at least thirty (30) days prior to the hearing, and shall be given orally from the pulpit at regular church services on two successive Sundays, the first of which shall be at least ten days prior to the hearing.
 - * The Clerk of Session and the Stated Clerk of Presbytery shall agree on the roster of active members, and the procedure for their registration at this hearing. Due diligence shall be exercised to ensure that only those eligible to vote do so.
 - * At least 66% of the active members shall be present.
 - * Members of the AC appointed by Presbytery shall be present throughout and shall have the right to speak.

st The question to be discussed is "Shall the $___$	Presbyterian Church request the
Presbytery to dismiss it to this Reformed body:	?"*

- * Ample time shall be provided for both speakers wanting dismissal and those wanting to stay with the PCUSA.
- * After discussion and prayer, a secret written ballot shall be taken on this question, the only choices being "Yes (Request dismissal)" or "No (Do Not request dismissal)."
- * If 90% of those active members present and voting vote to request dismissal, the request shall go to Presbytery. The result of this ballot shall be used by the Session in its discernment for dismissal. (Only the Session may request dismissal. Dismissal is not among those items of business that are proper to congregational meetings. G-1.0504)

The Board of Pensions is assessing and restructuring the Benefits Plan of the Presbyterian Church (U.S.A.) to meet the needs of a changing Church. Our hope is for all ministers and employees in the PC(USA) to be plan members. The Board of Directors will vote on a new Benefits Plan structure in early March. New Benefits Connect system now available

The new Benefits Connect system offers enhanced features and updated design and navigation to benefit church employers as well as individual members, both active and retired. Every user must register a new login for the new Benefits Connect. We encourage members and church employers to do so as soon as possible. Other important information:

The Assistance Program: As part of our commitment to mutual care and wholeness, the Board of Pensions continues to expand access to the Assistance Program to serve more ministers, employees, retirees, and surviving spouses who have financial need. Read about potential grant opportunities.

Remember to update Effective Salaries for the new year: Any changes to effective salaries must be reported to the Board of Pensions via Benefits Connect within 60 days of the effective date. New Medicare Advantage Plan with Humana has launched: The new plan replaced the former Medicare Supplement Plan for retired members, effective January 1, 2024. We anticipate potential expansion of eligibility in January 2025. <u>Read more about the Medicare Advantage Plan.</u>



Executive Council

The Executive Council met on December 14, 2023 and January 18, 2024.

The Executive Council received regular reports from Designated Presbyter Jodi Lingan and Stated Clerk David Vaughan. The Executive Council welcomed new Executive Presbyter Tony De La Rosa at the January meeting, and heard of his work in his initial half-month.

On behalf of Presbytery, the Executive Council took the following actions:

- Elected the following to service in Salem Presbytery:
 - * Rev. Randy Harris to the COM Task Force on the Care of Pastors and Retirees, Members-at-Large/Validated Oversight and Certified Christian Educator Oversight, Class of 2026;
 - * Rev. Andrew Taylor-Troutman to the Executive Council, Class of 2026;
 - * Elected the following to the Committee on Representation: Rev. Jay Lambeth, Rev. Sandy Kern, Rev. Sam Perkins all to the class of 2026;
- Extended the term of Elder David Vaughan as Stated Clerk, through August 31, 2024 (current term ends 2/28/2024);
- Approved Ruling Elders (who have been trained) to serve the Lord's Supper:
 - * Approved Elder Shannon Langston (a CRE candidate, certified ready to receive as commission) to serve the Lord's Supper at Bethesda/Statesville for one year beginning December 15, 2023;
 - * Approved Elder Wade Balsley (to be trained by Rev. Wes Pitts) to serve the Lord's Supper at Speedwell for one year beginning December 15, 2023;
 - * Approved Elder Nathan Peifer (a candidate under care of Salem Presbytery, certified by CPM as ready to receive a call) to celebrate the Sacraments and moderate the Session at Shallowford for six months, beginning January 1, 2024;
 - * Approved the following elders (having been trained by Rev. Olen Bruner) to serve the Lord's Supper at Allen Temple for one year beginning December 15, 2024: Elders Christopher Davis, Gretchen Dunlap, Robert Gaither, Leonard Hall, and James Miles;

Business of the Executive Council:

- Approved minutes of previous meetings, including the meetings of Presbytery in September and November 2023;
- At the recommendation of the Budget/Finance Committee, approved a payment in excess of the 2023 budget of \$25,000 as per capita payment to the Office of the General Assembly; this will allow Salem to pay nearly 73% of our OGA per capita assessment; the source of funding is proceeds from the sale of properties;
- For 2024, elected the Rev. Jennie Hemrick as Moderator and the Rev. Lara Musser-Gritter as Vice Moderator of the Executive Council;
- Authorized the Presbytery moderator, Dr. Hunter, to sign the deed transferring ownership of the property of the Stoneville PC which is officially sold;

- Approved the docket for the February 2024 meeting of Presbytery;
- Received notice that the Lloyd PC Session is requesting dismissal from the PC(USA); heard that the Stated Clerk was assembling an Administrative Commission to work alongside the Lloyd Session.

Faith Journey Rev. Dr. Sidney Davis

It would be so easy to say that my journey of faith started when I appeared before the ministers of the Yadkin Presbytery in the office of Rev. Dr. Peterson in Winston Salem or when I was taken under the care of the Southern Virginia Presbytery on June 1, 1974 or when I was ordained on June 1, 1977, but, I believe that my journey began as my grandmother would say when I was holding Church services in her living room and backyard.

I believe that my journey begun in the Sunday School Classrooms and Worship Services at Church Street Presbyterian Church (now Trinity Presbyterian Church) and my participation in the Westminster Fellowship activities of Catawba Inter- Presbytery Agency. My journey also began when I first realized that the young people of my apartment complex needed someone to care about their well-being and someone to be a positive role model.

My journey has not always been easy, fair, or just but I have found that I could not let go of God's hands. I had to remember the lessons of the Biblical saints like Job and Paul. Paul's words have given me so much guidance as I have struggled with challenges of life and ministry, for, he said in (Philippians 4:11-13) "11 I am not saying this because I am in need, for I have learned to be content whatever the circumstances. 12 I know what it is to be in need, and I know what it is to have plenty. I have learned the secret of being content in any and every situation, whether well fed or hungry, whether living in plenty or in want. 13 I can do all this through him who gives me strength."

In my faith journey God has shown me that when confronted with conflict, a good leader should always seek to find the common ground that may give all that are involved an opportunity to build trust and to work together to resolve the situation.

In my Seventy-two years of life, I have found that on this journey God have given me the opportunity to find peace, love, joy, and happiness! Statement of Faith Rev. Dr. Sidney Davis

Faith Journey Rev. Patricia Greene

As far back as I can remember, I have been drawn to church. I grew up in a family that attended church Sunday mornings, Sunday evenings, and Wednesday nights, and many other occasions when the church doors were open. The first church I remember attending was a small Baptist Church in the mountains of North Carolina, and my grandparents and parents were involved in leadership in various ways. While I did not see women serving in ordained positions, I was keenly aware of the holy ranks of women who served as teachers, music directors, hospitality providers, and encouragers. From a young age, I felt at home in the church, welcomed and loved, and I wanted to participate in that sacred space with people I cherished.

As the years passed, and I found myself living in a different geographical area, I began to see women serving in ordained positions. Even though I was not always consciously aware of it, my mind and heart began to open further to new possibilities for myself. While in college, I quickly gained appreciation for the scholarly world of religion and theology. However, despite my love for religious academia, I continued to feel drawn to the church, and my intersecting love for God, people, and church took me to seminary. It was there that I discovered a passion for preaching and worship that I never knew I possessed, and my gifts for pastoral care continued to develop. It was also there, in that Presbyterian school, that an appreciation of the PCUSA began to be kindled in me...an appreciation that has steadily evolved and has led me to this place today.

Since my time in seminary I have served two different churches as Pastoral Resident (PCUSA) and Associate Pastor/Minister to Families (Baptist). Both of these positions helped hone my ministry skills and awakened a confidence and competency in church leadership that was striking for me to see and feel. God was working through these opportunities and congregations to help me further discern my call.

In my last months of church work, I was recognizing within myself a restlessness and readiness for change. From my time in that small Baptist church in the mountains, I have had a particular affinity for senior adults, and I have discovered through the years that I have significant gifts when it comes to listening, companioning, and loving well. The groundwork was being laid for a move to hospice chaplaincy, and it is in this field that I have found a new home. Death and dying are sacred times, and I am grateful for the chance to walk with people as they near the end of their lives. There is great mystery in that time, and to be able to be a part of that holy journey for a person and family is beautiful work indeed. Reminding people

that they are beloved, helping them find meaning and significance in their lives, listening to their stories and providing space for grief in all its forms, these are but a few of the aspects of my job that I cherish and consider part of my ministry calling.

During these past few years, I have felt drawn back into the Presbyterian world to which my seminary first really introduced me. I will always be grateful for my Baptist heritage and ordination, but I feel God has been leading me for years toward this denominational turning point, and I am now ready to embrace it.

God has spoken through mentors, friends, family, and acquaintances to call out my gifts and to point me forward on this journey of love. God has used music, scripture, and other sacred writings to speak into my life, bringing clarity and hope.

Most central to my calling is my desire always to lean into love and to love people well...to seek the beauty in each person, remembering that the image of God is within us all...and to shine some light into this world and into people's lives.

Statement of Faith Rev. Patricia Greene

I believe in the One eternal God, Creator and Sustainer of the universe. Having existed from before time, God will continue to exist forever. God is utterly transcendent and immanent - outside of time and space, yet intimately present with creation. God desires relationship with the creation God personally crafted.

I believe in Jesus Christ, God's son, born of a woman. Fully divine and fully human, Jesus walked the earth with fellow humans as one of us but without sin, setting a profound example for humanity. In his life, death, and resurrection, he demonstrated power over sin and death and provided a salvific way by which creation could receive forgiveness and thereby more fully experience relationship with, and be reconciled to, God.

I believe in the Holy Spirit, permanently given to creation upon Jesus' ascension. As the indwelling presence of God that comforts and directs creation, the Holy Spirit is a mark of God's constant love and care for, and presence with, humanity. The Holy Spirit continually summons humans toward fuller relationship with God.

I believe one day Jesus will return in all Divine glory. A new heaven and new earth will be formed, and eventually, because of God's grace, love, and mercy, we will spend eternity in the presence of God. This belief provides the underpinning for Christian hope.

Faith Journey Rev. Julie M. Hill

The youngest of three girls, I was born and raised in Wilmington, NC. Bedtime Bible stories and prayers, Sunday school, and singing in the children's choir at church are among my earliest memories and formed the foundation of the faith I later claimed as my own. I was raised in the United Methodist Church where I grew in faith and experienced the joy of being part of a supportive and encouraging church community. After my faither died when I was seven, the emotional and tangible support we received from family, friends, and our church made it possible for my mother, who had never worked outside the home, to provide a stable environment for us. I learned the importance, indeed the necessity, of community. My elementary school days were marked by racial unrest in Wilmington, with curfews imposed and National Guard tanks patrolling the streets. This experience, along with seeing the struggles my mother faced as a single woman in the 1960's and 1970's, sealed within me a deep passion for issues of justice and equality.

It was at a summer church youth conference where I experienced the richness of personal devotional disciplines and the fellowship of other young devoted Christians, that I first felt God's call, though I did not understand it to be a call to ordained ministry. I pondered going into ministry when I graduated from Duke but did not have a clear sense of call and could not imagine me, a woman, as a pastor. For the next 20 years I collected catalogues and brochures from various seminaries and divinity schools.

I joined a Presbyterian Church in the mid 1980's, where the message of God's grace seeped into my soul and I had a role model of a woman in pastoral ministry. I threw myself into the life and ministry of that church and found my thirst for more only increased. It was in teaching a 5th grade Sunday school class entitled, "God Calls God's People," focusing on the call stories of Jacob, Joseph, Moses and others, and at the same time being asked to read the call of Jeremiah in worship, that I came to realize that God has always worked through flawed and unprepared people and that I must take the yearning I felt and God's call on my life seriously. Though life caused delays in pursuing my call, I entered the first class at Union Presbyterian Seminary in Charlotte in February 2002.

In a basic sense, my underlying faith has not changed since childhood. God is love. We are called into community and to nurture and support one another. Justice is an issue of faith. Yet I have grown- in understanding of my total dependence upon God's unfathomable grace, in appreciation for the mystery and freedom of God which is always beyond my ability to define or limit, and in hope, that goes beyond the immediate, to trust in the larger purposes of God that cannot be thwarted. In a world that often seems to be falling apart, I trust that God's kingdom will come. In the meantime, I am called to follow in the way of Jesus, assured that "nothing can separate us from the love of God in Christ Jesus our Lord."

Statement of Faith Rev. Julie M. Hill

Faith Journey

CRE Shannon Langston

I was born into, baptized, raised and confirmed in a Lutheran Church in Phoenix, Arizona. As a teen I went to youth group, helped in the younger kid's Sunday school classes, I went to church camp, and on mission trips. I always felt a pull towards the church and a greater understanding, constantly wanting to learn more. I ended up leaving the church my junior year of high school over differences with another youth, and because the pastor was was of no help.

In 2003, while my father in law was going through some health struggles, I met his pastor, her name is Pat, from their small Presbyterian church in Peoria, AZ. During that time I had become close friends with her, and AJ (my husband) and I started attending there more regularly, and basically didn't leave until we

moved to North Carolina in 2021. She is what inspired me to go into Christian education, and eventually part of the reason I went into pastoral leadership. She is still one of my best friends and biggest supporters today.

Over the course of the 18 or so years we were there I held many hats. I started off as a Sunday school teacher, then my final title for the last 10 years I was there, Director of Christian Education, in which I oversaw the entire program for birth through adults. I also started volunteeering for vacation Bible school, then stepped up to being the director for from 2004-2019. In 2014 I started serving on committees at the presbytery level, and enjoyed it immensely, and was the moderator of one of the committees from 2017-2020.

In 2015 I started taking classes at Austin Presbyterian Theological Seminary in their Certificate in Ministry program as a way to expand my understanding of the church, God, the Bible, Jesus and beyond. About 2 years into it I was talking to the Executive Presbyter of the Presbytery of the Grand Canyon about my classes. He asked if I was interested in becoming a CRE and he explained what it is. He said he thought I would be good at it, he had heard me do sermons at our youth group services several times and knows my compassion and passion for ministry. He urged me to pray on and talk to AJ about it. I found out that Austin PTS doesn't offer all of the courses I would need and though I had already taken 4 classes, only one would count toward the CRE program. So I transferred to University of Dubuque's Theological Seminary and was accepted into their Congregational Leadership Program, where they accepted the one class I took that did count as a transfer.

From the date I started at Austin, to the date I ended at Dubuque, it took me 8 and a half years to finish. That's also a total of 11 classes. Why did it take that long though? I took 1 class per semester, and none in the summers at first as I had young kids home from school, plus both my kids have some varying forms of mild mental special needs (now 17 and 18 years old), that required some undivided attention. Then there's me, I had struggled with some life threatening health issues in 2020-2021. So between my kids and I, I had to put things on hold sometimes. But, I never gave up! So after moving to North Carolina, getting everyone else settled into their job, and school, and all of us into a new house, I went back full force in August of 2022 and finished my last 3 classes, graduating in August 2023.

It took a bit of a journey to get here, but here I am, right where I belong!

Statement of Faith CRE Shannon Langston

I believe in the Bible, the inspired Words of God given to humanity. The Bible was written and collected by humanity to lead us into a relationship with God and have God's guidance throughout our lives. I believe the Bible is still relevant today, as we will always need God's guidance. I believe we need to adjust our understanding of the Bible with the changing world around us, in doing so I believe we make the Word of God more valuable, approachable, accepting and inclusive to all.

I believe in having a personal relationship with Scripture. To read, meditate on and discern what each passage is saying to me, and how to come to a better understanding of God's relationship within myself and with humanity though that text. Each time I come to Scripture and ask the Holy Spirit to guide to me, I learn something new and feel reinvigorated. Scripture inspires me to make better decisions for myself, my family, my church, the world around me and bring that knowledge into my ministry and mission.

I believe in God, who is the creator of all. I believe God continues to inspire all who come to God to be better and do better for God and for all of humanity. I believe God pulls us closer to God so we can have a personal relationship with God. All of us are created equally in God's perfect image, to be God's children, to love God and follow God.

I believe in Jesus Christ, the true Son of God. Who leads us so we may learn to love, understand and forgive, not only for ourselves, but all of our neighbors, whether believers of Christ or not. We come to Jesus

seeking salvation, grace and understanding each time we speak to him. 

Peace & Justice Task Force

Salem Presbytery's advocacy arm, connecting congregations and individuals to the justice movements happening in the bounds of Salem and beyond. *Meets monthly on the first Tuesday at 2:30 p.m.*

Permanent Judicial Commission

Meets when a legal case arises, only as needed.

Personnel Committee

Oversees personnel/human resource matters for the Presbytery office staff. *The Committee meets as needed.*

Presbyterian Youth Council - Adults

Plan and implement events for Middle and High School students in the Presbytery, providing an atmosphere of fun and fellowship while sharing the Good News of the gospel, comprised of youth and adults. *Meets on 3rd Saturdays during the school year, plus events.*

Property Management Task Force

Oversees real estate owned by Salem Presbytery, addressing any needs that arise. Meets as needed.

Mission Committee

Oversee the mission-related outreach and justice ministries for the Presbytery, and aids congregations in developing their own outreach and justice endeavors. Inspires and models local and global mission ministries. *Meets quarterly*.

Stewardship Committee

To build a culture of generosity through year-round stewardship efforts to support our Salem Presbytery, Synod, and General Assembly budget. *Meets on a non-recurring schedule.*
